Data Required by the Privacy Act of 1974

- 1. Authority:** 10 USC 3012; Art 53, Supplementary Agreement to NATO SOFA.
- 2. Principal purpose(s):** To record identifying data, purpose of visit, and time of visit of individuals who have been allowed to enter sensitive or other restricted U.S. facilities/installations.
- 3. Routine use(s):** To identify individuals who have entered sensitive or other restricted U.S. facilities/installations. See routine uses set forth in AR 340-21. Information may be disclosed to foreign law enforcement, security, investigatory, or administrative authorities in order to comply with requirements imposed by, or to claim rights conferred in, international agreements and arrangements, including those regulating the stationing and status in foreign countries of DOD military and civilian personnel.
- 4. Mandatory or voluntary disclosure and effect on individual not providing information:** Mandatory. Failure to provide any item of information will result in denial of entry onto U.S.-controlled installations for which this form has been validated.
