SUBJECT: Assessment of DoD/CENTCOM and Coalition Plans/Efforts to Train, Advise, and Assist the Iraqi Army to Defeat ISIL (Project No. D2015-D00SPO-0170.000)

We plan to begin the subject assessment immediately. This project relates to overseas contingency Operation Inherent Resolve, and will be completed in accordance with the OIG's oversight responsibilities, as described in Section 8L of the Inspector General Act of 1978, as amended. Our objective is to determine whether DoD/CENTCOM and Coalition goals. objectives, plans, guidance, operations, and resources to train, advise, and assist the Iraqi Army to defeat ISIL are operationally effective to initiate and sustain successful combat operations. We will consider suggestions from management on additional or revised objectives or for future assessments.

We plan to visit or contact organizations and individuals in the continental United States and in the U.S. Central Command area of responsibility that are responsible for training, advising, and assisting the Iraqi Army. Specific organizations to be visited will be identified before and during the field assessment, and arrangements for those visits will be made through established official points of contact.
