We plan to begin the subject audit in December 2011. Our audit objective will be to determine whether DoD officials properly awarded and administered task orders for the overhaul and modification of Mi-17 aircraft in accordance with Federal and DoD regulations and policies. Contracting officers issued the task orders under indefinite-delivery, indefinite-quantity contract number W58RGZ-09-D-0130. We will consider suggestions from management on additional or revised objectives.

We will perform the audit at the Non-Standard Rotary Wing Aviation Program Management Office in Redstone Arsenal, Huntsville, Alabama, and at the Army Contracting Command offices in Rock Island, Illinois, and Huntsville, Alabama. We also plan to meet with the administrative contracting officer from the Defense Contract Management Agency, personnel from the Defense Contract Audit Agency, and personnel from Science and Engineering Services Inc., the prime contractor. We may identify additional locations during the audit.
