## MEMORANDUM FOR DISTRIBUTION

SUBJECT: Audit of the Department of the Army (Treasury Index 21) Suspense Accounts (Project No. D2015-D000FI-0203.000)

This is the second in a series of four audits. During site visits in support of the Audit of the DoD Suspense Accounts (Project No. D2015-D000FE-0186.000), we determined that examining suspense accounts from the Treasury Index level is the most efficient and effective audit approach. We plan to begin the subject audit in June 2015. Our objective is to determine whether DoD has controls in place to record Department of the Army (Treasury Index 21) suspense account balances on the proper component-level financial statements. In addition, we will determine whether the accounts are being used for the intended purpose and transactions are resolved timely. We will consider suggestions from management on additional or revised objectives.

We will perform the audit at the Defense Finance and Accounting Service centers in Indianapolis, Indiana, and Columbus, Ohio. We may identify additional locations during the audit.
