We are reannouncing the subject audit, announced August 2, 2016 (attached), to inform you of changes to our objective. The original objective was to determine whether the Department of the Army is effectively managing the Chemical Demilitarization—Assembled Chemical Weapons Alternatives program cost, schedule and performance at Pueblo Chemical Agent—Destruction Pilot Plant and Blue Grass Chemical Agent—Destruction Pilot Plant. The reannounced objective is to determine whether the Office of the Secretary of Defense is effectively managing the Chemical Demilitarization—Assembled Chemical Weapons Alternatives program cost, schedule and performance. We will consider suggestions from management on additional or revised objectives.

We will perform the audit at the Program Executive Office Assembled Chemical Weapons Alternatives Aberdeen Proving Ground-Edgewood Arsenal, Maryland. We may identify additional locations during the audit.
