SURRY-SKIFFES CREEK

IMPACTS

- 57 resources listed, determined eligible for listing, or treated as eligible for listing
- Viewshed impacts to most resources including Jamestown Island, Colonial Parkway and Carters Grove
- Direct Impacts within Recently Established Historic District and across the Captain John Smith Chesapeake National Historic Trail
- Aquatic Resource impacts include 2,712 square feet of direct impacts to subaqueous bottom, discharge of fill material within 281 square feet of non-tidal wetlands, and conversion of 0.56 acres of palustrine forest wetlands to scrub shrub habitat
- Concerns regarding effects to navigation, aviation corridors, endangered species, and overall aquatic resource impacts have been resolved using the proper processes

PURPOSE

Install new 500kV aerial transmission lines and infrastructure across the James River between the Surry Nuclear Power Plant and the proposed new Skiffes Creek Switching Station, a 7.4-mile crossing of the James River w/ 17 towers at or up to 130'-295'. Upgrade an existing ~20 mile transmission right of way.

NEED


