AGREEMENT FOR USE PRIVILEGE

In return for receiving the use privilege of fishing for shellfish inhabiting waters subject to the jurisdiction of the State of Alaska, the undersigned agrees:

- (1) to engage in fishing for a species of shellfish only in a registration area, district or other subdivision of a registration area, for which the vessel is validly registered for that species;
- (2) to engage in fishing for a species of shellfish only in a registration area, district or other subdivision of a registration area, where the season is open for that species;
- (3) to engage in fishing for a species of shellfish in compliance with all regulations governing that species in the registration area, district or other subdivision of a registration area;
- (4) to comply with all reporting requirements, check-out provisions, gear configuration, storage and sharing requirements, and all other applicable regulations;
- (5) when required to carry an onboard observer the vessel operator consents to the placement of an observer aboard this vessel, if required, as a condition of participating in a fishery for which an onboard observer program is authorized by the Alaska Board of Fisheries.

The undersigned further agrees that the above agreement shall have the force of regulation.
