




PROPOSED PERMANENT IMPACT AREAS








APPROXIMATE LIMITS OF INTERMITTENT STREAM (PER WSSI OBSERVATIONS - NOT SURVEYED)




1. Topography, site boundary, and site design information provided by Walter L. Phillips, LLC was used as a base for this exhibit. The contour interval (C.I.) is 2 feet.

2. The boundaries of jurisdictional wetlands and other Waters of the United States (WOTUS) within the Scimores Academy project area were delineated and surveyed by Wetland Studies and Solutions, Inc. (WSSI) in November 2015. The results of this delineation are described in WSSI's report dated December 1, 2015. The U.S. Army Corps of Engineers (COE) verified the delineation with a jurisdictional determination (JD) dated January 19, 2016 (COE #NAO-2015-02175).

3. Limits of impacts to jurisdictional wetlands and other WOTUS shown hereon are based upon current development plans.

4. Note that the entire project area is within the Virginia Department of Historic Resources (VDHR) Architectural Resource 029-0268, Frying Pan Farm Park. The entire project area is also within the Floris Historic District (U.S. National Register of Historic Places).


