**Project Description:** The City of Hampton proposes to install a seasonal inflatable recreational water park approximately 340 feet north of Buckroe Fishing Pier and approximately 140 feet channelward of mean high water. The 147-foot by 165-foot aqua playground requires twenty-two B6 anchors and seven B4 Platipus anchors. The site will be accessed from the beach and anchors will be installed by hand with a turning bar or underwater torque motor. Anchors will remain buried under the soil year around. In the off-season, a buoy will be attached to each anchor point ensuring the cable is not lost.
