2/1/2018	2dCEB, 2dMarDiv	At a General Court-Martial at Camp Lejeune, North Carolina, Corporal R. L. Grant was convicted by a military judge of housebreaking, conspiracy to commit larceny, and larceny of military and personal property. The military judge sentenced the accused to 25 months confinement, a \$11,500.00 fine, reduction to E-1, and a bad-conduct discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 18 months.
2/2/2018	HqBn, MCB Hawaii	At a Special Court-Martial at Kaneohe Bay, Hawaii, Lance Corporal J. P. Cho was convicted by a military judge of wrongful use and introduction of controlled substances and conspiracy to introduce a controlled substance. The military judge sentenced the accused to 6 months confinement, reduction to E-1, and a bad-conduct discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 30 days.
2/2/2018	IMHG, IMEF	At a General Court-Martial at Camp Pendleton, California, Lance Corporal J. P. Hill was convicted by a military judge of sexual assault, abusive sexual contact, and indecent recording. The military judge sentenced the accused to 2 years confinement, total forfeiture of all pay and allowances, reduction to E-1, and a dishonorable discharge.
2/13/2018	HqSptBn, MCI-W MCB CamPen	At a Special Court-Martial at Camp Pendleton, California, Private A. M. Deruggiero was convicted by a military judge of unauthorized absence. The military judge sentenced the accused to 4 months confinement and a bad-conduct discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 90 days.
2/14/2018	CLR-3, 3dMLG	At a Special Court-Martial at Okinawa, Japan, Lance Corporal L. R. Starwalt was convicted by a military judge of child endangerment. The military judge sentenced the accused to reduction to E-1 and a reprimand. The pre-trial agreement had no effect on the sentence.

2/14/2018	MATSG-23, TrngCmd	At a General Court-Martial at Parris Island, South Carolina, Corporal G. Flores was convicted by a military judge of assault consummated by a battery. The military judge sentenced the accused to 5 days confinement, a \$3,000.00 fine, forfeiture of \$1,000.00 pay per month for a period of 3 months, and reduction to E-3. The pre-trial agreement had no effect on the sentence.
2/14/2018	2dBn, 6thMar, 2dMarDiv	At a Special Court-Martial at Camp Lejeune, North Carolina, Private First Class G. R. Tyler was convicted by a military judge of unauthorized absence, willful disobedience of a superior commissioned officer and noncommissioned officer, and assault upon a person in the execution of law enforcement duties. The military judge sentenced the accused to 7 months confinement and reduction to E-1. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of time served. At the time of trial, the accused had served 174 days in pre-trial confinement.
2/16/2018	MALS-13, MAG- 13, 3dMAW	At a General Court-Martial at Miramar, California, Lance Corporal L. M. Schmidt was convicted by a military judge of assault upon a noncommissioned officer, housebreaking, and false official statement. The military judge sentenced the accused to 150 days confinement, reduction to E-1, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
2/20/2018	3dBn, 8thMar, 2dMarDiv	At a General Court-Martial at Camp Lejeune, North Carolina, Lance Corporal A. J. Fragoso was convicted by a military judge of wrongful possession, use, and distribution of a controlled substance. The military judge sentenced the accused to 36 months confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 18 months.

2/21/2018	2dRTBn, RTR, MCRDPI	At a General Court-Martial at Parris Island, South Carolina, Gunnery Sergeant C. I. Anyadike was convicted by a military judge of robbery, aggravated assault, and rape. The military judge sentenced the accused to 35 years confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 15 years.
2/21/2018	SOI-E, TrngCmd	At a Special Court-Martial at Camp Lejeune, North Carolina, Sergeant N. A. Lenahan was convicted by a military judge of conspiracy to obstruct justice, willful disobedience of a superior commissioned officer, violation of a lawful general order, adultery, and obstructing justice. The military judge sentenced the accused to 90 days hard labor without confinement, reduction to E-2, and a reprimand. The pre-trial agreement had no effect on the sentence.
2/22/2018	CLB-4, CLR-3, 3dMLG	At a General Court-Martial at Okinawa, Japan, Lance Corporal A. M. Bradshaw was convicted by a military judge of attempted sexual assault of a child. The military judge sentenced the accused to 24 months confinement, total forfeiture of all pay and allowances, reduction to E-1, a reprimand, and a dishonorable discharge. The pre-trial agreement had no effect on the sentence.
2/22/2018	1stBn, 6thMar, 2dMarDiv	At a Special Court-Martial at Camp Lejeune, North Carolina, Private First Class J. J. Hawm was convicted by a military judge of wrongful distribution of a controlled substance. The military judge sentenced the accused to 6 months confinement and reduction to E-1. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 120 days.
2/24/2018	HqBty, 3dBn, 14thMar, 4thMarDiv	At a General Court-Martial at Quantico, Virginia, a master sergeant was acquitted by a panel of officer and enlisted members of sexual abuse of a child.

Lake was convicted by a military judge of disobeying a superior commissioned officer, violation of a lawful general order, false official statement, dereliction of duty, and adultery. The military judge sentenced the accused to 120 days confinement and reduction to E-1. The pre-trial agreement had no effect on the sentence.
2/28/2018	1stMRSB, MARSOC	At a General Court-Martial at Camp Pendleton, California, Petty Officer Third Class D. D. Upshaw was convicted by a panel of officer and enlisted members of sexual assault. The members sentenced the accused to 36 months confinement, reduction to E-1, and a dishonorable discharge.
