We announced the subject audit on November 14, 2017, (attached). The objective was to determine whether the DoD had a sustainable strategy for the Afghan Special Mission Wing to obtain, operate, and maintain non-standard rotary wing aircraft. We are terminating this audit because an ongoing audit of the Afghan Air Force reviewed the DoD strategy for obtaining, operating, and maintaining rotary wing aircraft for the Afghan Special Mission Wing. As a result, we have redirected our resources to focus on other high priority audits.

Our objective is to determine whether the DoD has a sustainable strategy for the Afghan Special Mission Wing to obtain, operate, and maintain non-standard rotary wing aircraft. We will consider suggestions from management on additional or revised objectives.

We will perform the audit at the Office of the Deputy Assistant Secretary of Defense for Afghanistan, Pakistan, and Central Asia, and the Office of the Deputy Assistant Secretary of Defense for Counternarcotics and Global Threats in Arlington, Virginia; the United States Central Command in Tampa, Florida; and the Program Executive Office for Aviation in Redstone Arsenal, Alabama.
