4/3/2018	H&HS Squadron, MCAS Miramar	At a Special Court-Martial at Miramar, California, a corporal was acquitted by a panel of officer and enlisted members of assault consummated by battery.
4/4/2018	MWSS-172, MAG-36, 1st MAW	At a Special Court-Martial at Okinawa, Japan, Master Sergeant D. Dickens was convicted by a military judge of making false official statements and larceny. The military judge sentenced the accused to reduction to E-7, a reprimand, and a \$6,000 fine. Pursuant to a pre-trial agreement the accused will serve 6 months confinement if the fine is not paid.
4/4/2018	1st Supply Bn, CLR-15, 1st MLG	At a General Court-Martial at Camp Pendleton, California, Lance Corporal A. Jordan Jr. was convicted by a panel of officer and enlisted members of aggravated assault by means and force likely to cause death or grievous bodily harm, disobeying a Staff NCO. The members sentenced the accused to a dishonorable discharge, 7 years confinement, and reduction to E-1.
4/6/2018	Marine Corps Air Facility, Quantico	At a General Court-Martial at Quantico, Virginia, Petty Officer Second Class J. Laramata was convicted by a military judge of abusive sexual contact. The military judge sentenced the accused to a dishonorable discharge, 30 months confinement, total forfeiture of all pay and allowances, and reduction to E-1. Pursuant to a pre-trial agreement all confinement in excess of 2 years will be suspended.
4/6/2018	MWSS-271, MAG-14, 2d MAW	At a Special Court-Martial at Cherry Point, North Carolina, Private L. Sims was convicted by a military judge of unauthorized absence, false official statement, and wrongful use, possession, and introduction of a controlled substance. The military judge sentenced the accused to 60 days confinement and a bad-conduct discharge. Pursuant to a pre-trial agreement, the convening authority agreed to disapprove the bad conduct discharge.
4/6/2018	1stBn, 11thMar, 1stMarDiv	At a Special Court-Martial at Camp Pendleton, California, Lance Corporal L. Martinez was convicted by a military judge of aggravated assault on a child under 16 years. The military judge sentenced the accused to 12 months confinement, reduction to E-1, and a bad conduct discharge. The pre-trial agreement had no effect on the sentence.

4/9/2018	CLR 25, 2dMLG	At a General Court-Martial at Camp Lejeune, North Carolina, Corporal C. Georgnersanchez was convicted by a military judge of aggravated assault. The military judge sentenced the accused to 10 months confinement, reduction to E-1, and a bad conduct discharge. The pre-trial agreement had no effect on the sentence.
4/9/2018	H&S Bn, MCB Camp Pendleton	At a Special Court-Martial at Camp Pendleton, California, Private A. Lopez was convicted by a military judge of unauthorized absence with apprehension. The military judge sentenced the accused to 90 days confinement and a bad conduct discharge. The pre-trial agreement had no effect on the sentence.
4/9/2018	VMU-3, MAG-24, 1stMAW	At a General Court-Martial at Kaneohe Bay, Hawaii, Private First Class M. Johnson was convicted by a panel of officer and enlisted members of attempted voluntary manslaughter. The members sentenced the accused to 18 months confinement, total forfeiture of all pay and allowances, reduction to E-1, and a bad-conduct discharge.
4/10/2018	HqRegt, 2dMLG	At a Special Court-Martial at Camp Lejeune, North Carolina, Corporal J. Marin was convicted by a military judge of disobeying a lawful general order, larceny of military property, conspiracy to wrongfully sell military property, and wrongful disposition of military property. The military judge sentenced the accused to 6 months confinement, reduction to E-1, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
4/11/2018	MWCS-28, MACG-28, 2dMAW	At a Special Court-Martial at Cherry Point, North Carolina, a Sergeant was acquitted by a panel of officer and enlisted members of breaching the peace and assault.
4/11/2018	9th Comm, 1 MHG, 1 MEF	At a Special Court-Martial at Camp Pendleton, California, Staff Sergeant M. Cardona was convicted by a military judge of fraternization, making false official statements, adultery, and obstruction of justice. The military judge sentenced the accused to 3 months confinement, reduction to E-1, and a bad conduct discharge. The pre-trial agreement had no effect on the sentence.

4/12/2018	HQ Bn, 1stMARDIV	At a General Court-Martial at Camp Pendleton, California, Sergeant B. Capers was convicted by a panel of officer and enlisted members of fraternization, and sexual harassment. The members sentenced the accused to 30 days confinement and reduction to E-2.
4/18/2018	SES Bn, MCI-W, MCB CamPen	At a Special Court-Martial at Camp Pendleton, California, Private First Class C. Russell was convicted by a military judge of wrongful use of a controlled substance. The military judge sentenced the accused to 2 months confinement, reduction to E-1, and forfeiture of \$800 per month for 2 months. The pre-trial agreement had no effect on the sentence.
4/19/2018	Weapons and Field Training Bn, MCB CamPen	At a Special Court-Martial at Camp Pendleton, California, Corporal D. Ledoux was convicted by a military judge of conspiracy to sell military property, selling military property, larceny of military property, making false official statements, obstructing justice, unlawful entry, and soliciting another to commit an offense. The military judge sentenced the accused to 4 months confinement, reduction to E-1, and a bad-conduct discharge. Pursuant to a pre-trial agreement all confinement in excess of 60 days will be suspended.
4/20/2018	1st Marine Raider Bn, Marine Raider Reg, MCB CamPen	At a Special Court-Martial at Camp Pendleton, California, Lance Corporal E. Golightly was convicted by a military judge of assault consummated by battery. The military judge sentenced the accused to 170 days confinement and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
4/23/2018	1/1 BLT, 31st MEU, III MEF	At a Special Court-Martial at Okinawa, Japan, Corporal T. Allison was convicted by a military judge of conspiracy to distribute a controlled substance and wrongful possession and distribution of a controlled substance. The military judge sentenced the accused to 8 months confinement, reduction to E-1, forfeiture of \$1,092.00 a month for 8 months, reprimand, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.

4/24/2018	Weapons and Field Training Bn, MCB CamPen	At a Special Court-Martial at Camp Pendleton, California, Corporal B. Vonarx was convicted by a military judge of conspiracy to sell military property, selling military property, larceny of military property, obstructing justice, unlawful entry, and soliciting another to commit an offense. The military judge sentenced the accused to 5 months confinement, reduction to E-1, and a bad-conduct discharge. Pursuant to a pre-trial agreement all confinement in excess of 60 days will be suspended.
4/24/2018	MAG-24, 1st MAW	At a Special Court-Martial at Kaneohe Bay, Hawaii, Sergeant J. Selvajones was convicted by a military judge of wrongful use of a controlled substance. The military judge sentenced the accused to 90 days confinement, reduction to E-1, and bad conduct discharge. Pursuant to pre-trial agreement the accused waived his administrative board and the punitive discharge will be remitted. Additionally, all confinement in 45 days will be suspended.
4/25/2018	10thMarRegt, 2dMARDIV	At a Special Court-Martial at Camp Lejeune, North Carolina, Sergeant I. Jones was convicted by a military judge of assault consummated by battery and hazing. The military judge sentenced the accused to 90 days confinement and reduction to E-3. and a dishonorable discharge. The pre-trial agreement had no effect on the sentence.
4/26/2018	Marine Corps Recruit Depot/Western Recruiting Region, San Diego, CA	At a General Court-Martial at San Diego, California, Lance Corporal F. Rayon was convicted by a panel of officer and enlisted members of violating a general order. No punishment was awarded.
4/26/2018	HQrgt, 2dMLG	At a General Court-Martial at Quantico, Virginia, Master Sergeant L. Coon was convicted by a panel of officer and enlisted members of assault and battery on a child under the age of 16, obstruction of justice, violating a civilian protective order, child endangerment, and adultery. The members sentenced the accused to 60 days confinement, reduction to E-6, and forfeiture of \$1,000 a month for 1 month.
4/26/2018	MWCS-18, MACG-18, 1stMAW	At a Special Court-Martial at Okinawa, Japan, a Lance Corporal was acquitted of abusive sexual contact.

4/30/2018	HMLA-367, MAG-24, 1stMAW	At a General Court-Martial at Miramar, California, Corporal T. Sparks was convicted by a military judge of violating a lawful order, wrongful use of a controlled substance, assault consummated by battery, adultery, and obstruction of justice. The military judge sentenced the accused to 3 years confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 36 months.
4/30/2018	3D Intelligence Bn, III MEF	At a Special Court-Martial at Okinawa, Japan, Gunnery Sergeant R. Rossington was convicted by a military judge of making false official statements and larceny. The military judge sentenced the accused to 179 days confinement, reduction to E-4, fine of \$66,000, and a reprimand. Pursuant to a pre-trial agreement, if the fine is not paid the accused will serve an additional 6 months confinement.
