## AT A GLANCE


The fourth annual comprehensive oversight plan submitted by the Lead Inspector General for Operation Inherent Resolve (OIR), Afghanistan to include Operation Freedom's Sentinel (OFS), Operation Pacific Eagle–Philippines (OPE-P), as well as governance, humanitarian assistance, and stabilization programs.


