9/6/2018	TECO, HqSvc Bn, MCB Quantico	At a Special Court-Martial at Marine Corps Base Quantico, Virginia, Sergeant L. J. Smith was convicted by a panel of officer and enlisted members of wrongful use of marijuana. The members sentenced the accused to a \$100.00 fine and a reprimand.
9/7/2018	HQReg, 2d MLG	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal O. D. Gary of conspiracy to commit wrongful distribution of a controlled substance and wrongful distribution of a controlled substance. The military judge sentenced the accused to 100 days confinement, reduction to E-1, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
9/7/2018	1st Dental Bn, 1st MLG	At a General Court-Martial at Camp Pendleton, California, a panel of officer and enlisted members convicted Hospitalman H. L. McGill of conspiracy to kidnap, disobeying a lawful order, obstruction, and larceny. The members sentenced the accused to reduction to E-1, confinement for 18 months, forfeiture of all pay and allowances, and a bad-conduct discharge.
9/11/2018	MALS-13, MAG- 13, 3d MAW	At a General Court-Martial at Marine Corps Air Station Yuma, Arizona, a military judge convicted Lance Corporal G. A. Davis of assault, negligence, and disrespect to a commissioned officer. The military judge sentenced the accused to reduction to E-1, 6 months confinement, and a bad-conduct discharge. The pretrial agreement had no effect on the sentence.
9/11/2018	MASS-3, MACG- 38, 3d MAW	At a General Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Sergeant A. A. Nelson of indecent communication with a child. The military judge sentenced the accused to reduction to E-1, 12 months confinement, forfeiture of all pay and allowances, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 10 months.
9/13/2018	1st Recon Bn, 1st MARDIV	At a General Court-Martial at Marine Corps Base Camp Pendleton, California, a panel of officer and enlisted members convicted Corporal A. J. Hanabarger of sexual assault. The members sentenced the accused to reduction to E-1, 4 years confinement, total forfeitures, and a dishonorable discharge.

9/14/2018	HqSvcBn, MARFORCOM	At a General Court-Martial at Marine Corps Base Quantico, Virginia, a panel of officer and enlisted members acquitted a Sergeant of charges of attempts, sexual harassment, sexual assault, abusive sexual contact, and soliciting another to commit an offense.
9/24/2018	7th Mar, 1st MARDIV	At a General Court-Martial at Marine Corps Air Ground Combat Center Twentynine Palms, California, a military judge convicted 2ndLt W. L. Coville of maiming, drunk and disorderly, and conduct unbecoming. The military judge sentenced the accused to 12 months confinement and a dismissal. The pre-trial agreement had no effect on the sentence.
9/25/2018	CLB-11, HqReg, 1st MLG	At a General Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Corporal T. Saechao of conspiracy to commit larceny, conspiracy to sell military property, unauthorized sale of military property, and soliciting another to commit an offense. The military judge sentenced the accused to reduction to E-1, 13 months confinement, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
9/26/2018	7th ESB, 1st MLG	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Corporal O. Esquivelestrada of driving under the influence and fleeing the scene of an accident. The military judge sentenced the accused to reduction to E-1, 4 months confinement, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
9/28/2018	CLB-7, 1st MLG	At a Special Court-Martial at Marine Corps Air Ground Combat Center Twentynine Palms, California, a panel of officer and enlisted members acquitted a Gunnery Sergeant of failure to obey a general order and fraternization.
