PRIVACY ACT STATEMENT

AUTHORITY: Section 3012, Title 10 to U.S. Code.
PURPOSE: Used by Natural Resource Management Personnel to identify individual applicants for Special Permit Hunts at Fort Chaffee.
ROUTINE USE: To identify duplicate permits; to identify possible violations of Fort Chaffee Maneuver Training Center regulations; to Federal, State and local Law Enforcement Agency for possible violation of civil and criminal law; and to Arkansas Game and Fish Commission for fish and wildlife enforcement.
DISCLOSURE: Voluntary; failure to do so may result in disqualification.

HUNTING PERMIT APPLICATION INSTRUCTIONS

This application is for **CATEGORY I APPLICANTS ONLY**. Category I status includes active-duty military, traditional guard, reserve members, 30% or greater military disabled, retired military, Department of Defense full-time civilians employed at Fort Chaffee Maneuver Training Center and their spouses and dependent children (**those under 21 living at home**). *Proof of status/identification **MUST** accompany applications*.

Fort Chaffee Maneuver Training Center officials administer permits for the Muzzleloader and Modern Gun deer hunts on Fort Chaffee Maneuver Training Center. All fees collected through this program will be used exclusively on Fort Chaffee Maneuver Training Center to manage the fish and wildlife resources.

The following rules apply to the **2014 MODERN GUN AND MUZZLELOADER CATEGORY I** permit hunts:

1. Applicants must use the application form found on the front side of these instructions. Applicants must use a separate application for each hunt. Application forms must be completely filled out and be accurate and legible.
2. The sponsor's signature must be on every application.
3. Permits will be one (1) one-day hunt.
4. CATEGORY I permits are limited to 10 percent of the total permits available. A Category I random drawing will be held if there are more applicants than permits. **IF YOU APPLY FOR A CATEGORY I PERMIT, YOU MAY NOT APPLY FOR A CATEGORY II PERMIT**. If you are not drawn for a Category I permit, your application will **NOT** be forwarded to the Arkansas Game and Fish Commission's Category II permit drawing. If you apply for both hunts, Category I and Category II your permit will be revoked.

Application packets can be delivered in person to the Environmental Division Office (Building 1370) or mailed (postmarked on or before 30 June 2014) to FCMTC-EN-E, Bldg. 1370, Fort Smith Blvd., Fort Chaffee, AR 72905
ATTN: Category I Special Hunt. Faxed or emailed applications will NOT be accepted.

6. **BANK CASHIER'S CHECKS, MONEY ORDERS OR PROOF OF EXEMPTION (IF APPLICABLE) MUST BE RECEIVED BEFORE PERMITS CAN BE ISSUED. NO CASH OR PERSONAL CHECKS WILL BE ACCEPTED. MAKE BANK CASHIER'S CHECKS OR MONEY ORDERS PAYABLE TO U.S. TREASURY.**
7. Applicants age 15 years and under, veterans with a 30% or higher service related disability and persons 65 years and older are not required to pay the \$10 fee. **PROOF OF EXEMPTION MUST ACCOMPANY ALL APPLICATIONS**. Arkansas Game and Fish lifetime license holders are required to pay the \$10 fee, unless they are excluded by age (noted above) or a veteran with a 30% or higher service related disability.
8. Permit hunt dates are subject to change. If a particular hunt cannot occur as scheduled, it will be rescheduled on a different date. Under no circumstance will refunds be available. **PERMITS ARE NONTRANSFERABLE.**
9. **ANY DEER HARVESTED ON FORT CHAFFEE MANEUVER TRAINING CENTER DURING THE 2014 MUZZLELOADER AND MODERN GUN SEASONS WILL NOT BE CLASSIFIED AS A BONUS DEER**. Any deer taken will be included in the bag limit set forth by the Arkansas Game and Fish Commission. No dogs are permitted.
10. **PERSONS ENTERING FORT CHAFFEE MANEUVER TRAINING CENTER MUST ATTEND A SPORTSMAN ORIENTATION CLASS** and comply with post regulations. Class schedules and renewal information are available at (479) 484-3596. **Special hunt permit holders are required to attend the orientation class and possess a current sportsman (\$20 fee) or recreational (\$5 fee) permit in order to gain access and participate**. To renew expired permits, proof of orientation dated January 1, 1999 or after must be provided. ***SPORTSMAN PERMITS WILL NOT BE RENEWED AT THE GATES ON THE DAY OF THE SPECIAL HUNTS**.* The authorized gates for access are Gate 16 and Gate 22 for the special hunt. Gates open at 4:30 a.m.
11. Applicants who are drawn will be notified by mail during the first week of September and ***payment or proof of exemption must be received in the Environmental Office no later than 1 October or permits will be forfeited and reissued**.*
