2/1/2019	MCCSSS, TrngCmd	At a Special Court-Martial at Camp Lejeune, North Carolina, a panel of officer and enlisted members convicted Private First Class T. A. Irvin of failure to obey a lawful order, restriction breaking, willful discharge of a firearm, unauthorized absence, willful disobedience to a superior commissioned officer, and wrongful use of a controlled substance. The members sentenced the accused to 12 months confinement, reduction to E-1, and a bad-conduct discharge.
2/1/2019	HMLA-169, MAG-39, 3d MAW	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Corporal J. D. OrtaSantiago, pursuant to his pleas, of unauthorized use and distribution of a controlled substance and soliciting another to commit an offense. The military judge sentenced the accused to reduction to E-1, 8 months confinement, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will suspend all confinement in excess of 90 days.
2/11/2019	3d BN, 5th MAR, 1st MARDIV	At a General Court-Martial at Marine Corps Base Camp Pendleton, California, a panel of officer and enlisted members convicted Corporal J. D. Shockey III of disobeying an order from a commissioned officer, false official statement, and assault. The members sentence the accused to reduction to E-2 and a reprimand.
2/12/2019	CLR-17, 1st MLG	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Private First Class P. J. Burke, pursuant to his pleas, of wrongful use of a controlled substance. The military judge sentenced the accused to reduction to E-1, 4 days confinement, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will suspend the bad-conduct discharge.
2/12/2019	1st BN, 8th MAR, 2d MARDIV	At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Staff Sergeant D. J. Barlow II, pursuant to his pleas, of larceny of personal property, obstructing justice, and conspiracy to commit larceny. The military judge sentenced the accused to 14 months confinement, reduction to E-1, and a bad-conduct discharge.

2/12/2019	H&S CO, Marine Corps Security Force Regiment	At a Special Court-Martial at Marine Corps Base Quantico, Virginia, a military judge convicted Lance Corporal T. E. Ramsey, pursuant to his pleas, of wrongful introduction and distribution of a controlled substance. The military judge sentenced the accused to reduction to E-1, 180 days confinement, and a bad-conduct discharge.
2/12/2019	H&S CO, 2d MED BN, 2d MLG	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal D. D. Short, pursuant to his pleas, of assault consummated by battery and resisting apprehensions. The military judge sentenced the accused to 60 days confinement, reduction to E-1, and a bad-conduct discharge.
2/13/2019	2d BN, 7th MAR, 1st MARDIV	At a Special Court-Martial at Marine Corps Air Ground Combat Center Twentynine Palms, California, a military judge convicted Lance Corporal L. A. McClary, pursuant to his pleas, of larceny. The military judge sentenced the accused to reduction to E-1, 12 months confinement, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will grant one day of confinement credit for every two days of pretrial restriction; to suspend all confinement in excess of six months; and to defer automatic forfeitures in the amount of \$378.00 per month.
2/14/2019	VMFA-323, MAG-11, 3d MAW	At a General Court-Martial at Marine Corps Air Station Miramar, California, a military judge convicted Lance Corporal J. E. Lloyd, pursuant to his pleas, of wrongful use, distribution, and introduction of a controlled substance, and assault consummated by battery. The military judge sentenced the accused to 24 months confinement and a dishonorable discharge. Pursuant to the pretrial agreement, the convening authority will suspend confinement in excess of 13 months.
2/14/2019	1st BN, 10th MAR, 2d MARDIV	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal M. A. Freeze, pursuant to his pleas, of wrongful use of a controlled substance. The military judge sentenced the accused to 90 days confinement and reduction to E-1. Pursuant to the pretrial agreement, any confinement in excess of time served is suspended.

The military judge sentenced the accused to 7 years confinement, reduction to E-1, total forfeitures, and a dishonorable discharge. Pursuant to the pretrial agreement, all confinement in excess of 30 months will be suspended.
2/14/2019	H&HS, MCAS Futenma	At a General Court-Martial at Marine Corps Base Camp Smedley D. Butler, a military judge convicted Corporal C. E. Sullivan, pursuant to his pleas, of wrongful introduction, possession of a controlled substance with the intent to distribution, distribution, and wrongful use of a controlled substance. The military judge sentenced the accused to 27 months confinement, reduction to E-1, total forfeitures, and a dishonorable discharge. Pursuant to the pretrial agreement, all confinement in excess of 24 months will be suspended.
2/19/2019	HMLA-169, MAG-39, 3d MAW	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Corporal I. L. Granja, pursuant to his pleas, of wrongful use and distribution of a controlled substance. The military judge sentenced the accused to reduction to E-2, 63 days confinement, and a bad-conduct discharge. Pursuant to a plea agreement, the convening authority will suspend all confinement in excess of 60 days.
2/20/2019	3d Bn, 1st MAR, 1st MARDIV	At a General Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Corporal K. J. Nagel, pursuant to his pleas, of attempting lewd acts upon a child and sexual abuse of a child not involving sexual contact. The military judge sentenced the accused to reduction to E-1, 60 days confinement, and a bad-conduct discharge.

Sanchez, pursuant to his pleas, of wrongful use and possession of a controlled substance, aggravated assault, and assault. The military judge sentenced the accused to reduction to E-1, total forfeitures, 4 years confinement, and a dishonorable discharge. Pursuant to the pretrial agreement, the convening authority will suspend all confinement in excess of 36 months; disapprove adjudged forfeitures and defer and waive automatic forfeitures provided that the accused establish and maintains an allotment for the benefit of his dependents.
2/21/2019	HMLA-169, MAG-39, 3d MAW	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Lance Corporal A. D. Perez, pursuant to his pleas, of wrongful use and possession of a controlled substance. The military judge sentenced the accused to reduction to E-1, 120 days confinement, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will suspend all confinement in excess of 90 days.
2/21/2019	HMLA-169, MAG-39, 3d MAW	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Sergeant C. J. Parsons, pursuant to his pleas, of distribution of a controlled substance. The military judge sentenced the accused to reduction to E-1, forfeiture of \$1,120.00 per month for 6 months, a fine of \$1,000.00, 65 days confinement, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will disapprove the fine.
2/27/2019	TBS	At a Special Court-Martial at Marine Corps Base Quantico, Virginia, a second lieutenant was acquitted by a panel of officer of wrongful use of a controlled substance and conduct unbecoming an officer and gentleman.

Pursuant to the pretrial agreement, the convening authority will suspend all confinement in excess of 36 months.

Pursuant to the pretrial agreement, the convening authority will suspend all confinement in excess of 90 days.
2/27/2019	5th BN, 11th MAR, 1st MarDiv	At a Special Court-Martial at Marine Corps Base Camp Pendleton, California, a military judge convicted Sergeant G. A. Chavez, pursuant to his pleas, of use and distribution of a controlled substance. The military judge sentenced the accused to reduction to E-1, 89 days confinement, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will suspend the bad-conduct discharge.
