11/1/2019	2d Bn 3d Mar Regt 3d MARDIV	At a Special Court-Martial at Marine Corps Base Hawaii, a military judge convicted Lance Corporal W. A. Russell, consistent with his pleas, of use of a controlled drug and drunk and disorderly. Consistent with the plea agreement, the military judge sentenced the accused to a bad-conduct discharge, 90 days confinement (consisting of four consecutive 90 days terms and a 30 day term), forfeiture of \$1,100 pay per month for a period of 3 months, and reduction to E-1.
11/6/2019	2d MARDIV	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Master Gunnery Sergeant J. L. Kaus, consistent with his pleas, of a violation of a general order. The military judge sentenced the accused to reduction to E-7 and a written reprimand.
11/6/2019	1st Bn 5th Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal D. R. Spykerman, pursuant to his pleas, of unlawfully transporting, for private financial gain, aliens who entered the United States illegally. Consistent with the plea agreement, the military judge sentenced the accused to 98 days confinement, reduction to E-1, forfeiture of \$1,000 pay per month for 4 months, and a bad-conduct discharge.
11/7/2019	MALS-16 MAG-16 3d MAW	At a Special Court-Martial at Marine Corps Air Station Miramar, a panel of officer and enlisted members convicted Sergeant B. A. Tucker of unauthorized absence. The members sentenced the accused to 30 restriction, 30 days hard labor, and reduction to E-3.
11/8/2019	3d MAW	At a General Court-Martial at Marine Corps Air Station Miramar, a panel of officer and enlisted members acquitted a Corporal of false official statement, rape, and aggravated assault.
11/13/2019	5th Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal R. J. Scott, consistent with his pleas, of battery. The military judge sentenced the accused to reduction to E-1 and 90 days confinement.

11/14/2019	H&S Bn MCRD PI	At a Special Court-Martial at Marine Corps Recruit Depot Parris Island, a military judge convicted Lance Corporal W. E. Garner II of assault. The military judge sentenced the accused to 15 days hard labor and reduction to E-2.
11/14/2019	MARINE CORPS INTELLIGENCE AGENCY	At a Special Court-Martial at Marine Corps Base Quantico, a military judge convicted Sergeant P. L. Ewing, consistent with his pleas, of false official statement, solicitation, and willful dereliction of duty. The military judge sentenced the accused to 2 months confinement, reduction to E-1, and bad-conduct discharge.
11/14/2019	4th Tank Bn 4th MARDIV	At a Special Court-Martial at Marine Corps Base Quantico, a military judge convicted Gunnery Sergeant S. R. Alderman, consistent with his pleas, of disrespect towards a superior commissioned officer in command, damaging non-military property, breach of peace, disorderly conduct, and negligently discharging a firearm. Consistent with the plea agreement, the military judge sentenced the accused to 30 days confinement and reduction to E-6.
11/18/2019	MCI-EAST	At a General Court-Martial at Marine Corps Camp Lejeune North Carolina, a military judge convicted Corporal C. A. Anderson Honeycutt, consistent with his pleas, of assault consummated by battery, violation of a lawful general order, false official statement, adultery, communicating a threat, and extramarital sexual conduct. The military judge sentenced the accused to 17 months confinement, reduction to E-1, and a bad-conduct discharge.
11/18/2019	1st Bn 11th Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal J. A. Ruedas, consistent with his pleas, of wrongful use, distribution, and introduction of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 25 days confinement, reduction to E-1, and a bad-conduct discharge.
11/18/2019	1st MARDIV	At a General Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal B. A. Welsh, consistent with his pleas, of obstructing justice and violating a lawful general order. The military judge sentenced the accused to 18 months confinement, total forfeiture of all pay and allowances, reduction to E-1, and a bad-conduct discharge.

11/19/2019	1st MLG	At a General Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal F. L. Ehasz, consistent with his pleas, of aggravated assault upon a child under the age of 16. The military judge sentenced the accused to 10 years confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority will suspend all confinement in excess of 96 months, and all automatic forfeitures will be deferred and waived provided the accused maintains a dependent's allotment.
11/20/2019	MALS-16 MAG-16 3d MAW	At a Special Court-Martial at Marine Corps Air Station Miramar, a military judge convicted Lance Corporal W. M. Pippen of use of a controlled substance. The military judge sentenced the accused to reduction to E-1 and 30 days confinement.
11/20/2019	MCAS IWAKUNI	At a General Court-Martial at Marine Corps Air Station Iwakuni, Japan, a military judge convicted Lance Corporal Christopher Z. Higgs, pursuant to his pleas, of failure to obey other lawful order, violation of a lawful general order, and adultery. The military judge sentenced the accused to 2 months confinement, forfeiture of \$1,000 per month for a period of 2 months, and reduction to the paygrade E-1.
11/20/2019	7th Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Air Ground Combat Center Twentynine Palms, a military judge convicted Sergeant J. I. Escudero of wrongful use of a controlled substance. The military judge sentenced the accused to 60 days restriction and reduction to E-3.
11/20/2019	1st Bn 5th Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal J. Carrillo, pursuant to his pleas, of unlawfully transporting, for private financial gain, aliens who entered the United States illegally. Consistent with the plea agreement, the military judge sentenced the accused to 118 days confinement and reduction to E-1.

11/20/2019	2d MLG	At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal Z. E. Thomas, consistent with his pleas, of attempted sexual abuse of a child by indecent communication, attempted sexual assault of a child, attempted adultery, and false official statement. The military judge sentenced the accused to 440 days confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority will suspend all confinement in excess of 18 months.
11/21/2019	7th ESB 1st MLG	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal J. M. Juarez, consistent with his pleas, of child endangerment. The military judge sentenced the accused to 5 days confinement, reduction to E-3, and a reprimand.
11/21/2019	MAG-14 2d MAW	At a Special Court-Martial at Marine Corps Air Station Cherry Point, a military judge convicted Staff Sergeant A. J. Goodson of wrongful use of a controlled substance. The military judge sentenced the accused to reduction to E-3.
11/22/2019	2d MLG	At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Staff Sergeant A. K. Davis, consistent with his pleas, of possession, production, receipt, and distribution of child pornography and indecent recording. The military judge sentenced the accused to 10 years confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority will suspend all confinement in excess of 48 months.
11/22/2019	1st Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal J. D. Caruso, consistent with his pleas, of violation a lawful general order, unlawfully carrying a concealed weapon, and unlawfully transporting, for private financial gain, aliens who entered the United States illegally. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1, a reprimand, 10 months confinement (consisting of two concurrent 6 month terms, and one consecutive 4 month term), and a bad-conduct discharge.

11/25/2019	1st Bn 11th Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal J. A. Rivera, consistent with his pleas, of willfully disobeying a superior commissioned officer and wrongful use and introduction of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 60 days confinement (consisting of three consecutive 60 day terms), forfeiture of \$1,120 pay per month for 2 months, reduction to E-1, and a bad-conduct discharge.
11/26/2019	1st Bn 1st Mar Regt 1st MARDIV	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal J. C. Somero, consistent with his plea, of distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 30 days confinement, forfeitures of \$500 pay per month for one month, and reduction to E-1.
11/26/2019	2d MAW	At a General Court-Martial at Marine Corps Recruit Depot Parris Island, a military judge convicted Corporal J. C. Mize, consistent with his pleas, of use, possession, distribution, and introduction of a controlled substance. The military judge sentenced the accused to 20 months confinement (consisting of two 20 month terms and two 13 month terms running concurrently), total forfeiture of all pay and allowances, reduction to E-1, and a bad-conduct discharge. Pursuant to a pre-trial agreement, the convening authority will suspend all confinement in excess of 20 months.
11/27/2019	MCCES TECOM	At a Special Court-Martial at Marine Corps Air Ground Combat Center Twentynine Palms, a military judge convicted Private K. Maravarman, consistent with his pleas, of failure to obey a lawful written order and wrongful use of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 55 days confinement, forfeiture of \$1,100 for 1 month, 30 days restriction, and a bad-conduct discharge.
