SUBJECT: Authorities, Roles, and Responsibilities Delegated to USAREUR General Officers and Members of the Senior Executive Service (AE Cmd Memo 2018-044)

This memorandum expires on 2 December 2019.

1. Supersession. This memorandum supersedes memorandum, USAREUR, AECS, 19 July 2018, subject: Terms of Reference for USAREUR General Officers and Members of the Senior Executive Service and the Roles and Responsibilities of the USAREUR Command Group (AE Cmd Memo 2018-035).

3. Purpose. This memorandum provides an overview of the authorities, roles, and responsibilities of the general officers (GOs), members of the Senior Executive Service (SES), and members of the Defense Intelligence Senior Level (DISL) associated with USAREUR by assignment, operational control, administrative control (ADCON), tactical control, or tenancy in the USAREUR area of responsibility. The forthcoming update to [AE Regulation 10-5](#) will describe these authorities, roles, and responsibilities in detail.

a. The GOs are the following:

- The Commanding General, USAREUR (CG, USAREUR)
- The Deputy Commanding General, USAREUR (DCG, USAREUR)
- The Deputy Commanding General for Sustainment (DCG-S)/Commanding General, 21st Sustainment Command (CG, 21st SC)
- The Deputy Commanding General, Army National Guard, USAREUR (DCG-ARNG, USAREUR)
- The Deputy Commanding General, Mobilization and Reserve Affairs, USAREUR (DCG-M&RA, USAREUR)
- The Chief of Staff, HQ USAREUR
- The Deputy Chief of Staff, Operations, USAREUR
- The Commanding General, United States Army Africa/Southern European Task Force (CG, USARAF/SETAF)
- The Commanding General, 7th Army Training Command (CG, 7th ATC)
- The Commanding General, 10th Army Air and Missile Defense Command (CG, 10th AAMDC)
- The Commanding General, 7th Mission Support Command (CG, 7th MSC)
- The Commanding General, Regional Health Command Europe (CG, RHCE)
- The Commander, Mission Command Element (Provisional) (Cdr, MCE (Prov))
- The Deputy Chief of Staff, G6, USAREUR

b. The members of the SES and DISL are the following:

- The Director, United States Army Installation Management Command Europe (Director, IMCOM-Europe)
- The Deputy Chief of Staff, G5, USAREUR
- The Deputy Chief of Staff, G8, USAREUR
- The Special Advisor to the USAREUR G2 (DISL)

4. Authorities Delegated to GOs and SES Members.


a. The CG, USAREUR, is the commander of an Army service component command (ASCC), and he is the European theater Army commander. As an ASCC and theater Army commander, the CG executes senior-commander duties specified in AR 600-20 while reporting to two chains of command. The CG may delegate certain authorities pursuant to these duties, but cannot delegate the responsibility of command.

b. In view of the above, I have delegated to GOs and SES members the authorities listed in the [table at enclosure 2](#). The delegated authorities include the following: senior responsible officer (SRO), general officer for force protection (GOFP), and training review authority (TRA).

c. General court martial convening authority (GCMCA) is designated by the Secretary of the Army. The [table at enclosure 2](#) provides the current alignment of area jurisdiction among subordinate USAREUR GCMCAs.
