Yaquina Bay Entrance Lighted Buoy 3 (LLNR 9600) was reported missing from station by CG STA Yaquina Bay at 0700 this morning.

The buoys is an 8x26 LB, seasonally commissioned on 6/19/2018, usually disestablished by October 1st.

There is approximately 180 feet of 1-7/8 inch chain (90' chafe, 90' bottom) and the sinker is 18,000 concrete. Current hull # is 8-17-79. It has a SC-LED lantern on it.

Last recorded ocean surface currents were showing south by southwest at 40 centimeters an hour (0.78 knots)
