



### Is Non-Selection for a Position a Form of Discrimination?

In a recent case, Darius C., Complainant, v. Department of Treasury (US Mint), EEOC Appeal No. 0120181094 (June 25, 2019), the Equal Employment Opportunity Commission (EEOC) found that the US Mint did not discriminate against an employee based on disability and age. The Complainant alleged that since a temporary promotion was not advertised, he was not given the opportunity to apply. He also claimed that the US Mint did not refer him for other positions for which he was qualified and met requirements. The EEOC decided that the US Mint was not required to announce the temporary promotion since it would not exceed 120 days. Furthermore, the agency articulated legitimate, non-discriminatory reasons for not considering the Complainant for the other positions. The EEOC found the Complainant failed to prove his claims of discrimination. By Ms. Elizabeth Mercado, CRD, USGG HQ
