5/1/2018	HQRegt, 2dMLG	At a Special Court-Martial at Camp Lejeune, North Carolina, Lance Corporal B. A. Smith was convicted by a military judge of accessory after the fact and false official statement. The military judge sentenced the accused to 6 months confinement, reduction to E-1, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
5/2/2018	H&HS, MCAS Iwakuni	At a Special Court-Martial in Okinawa, Japan, Lance Corporal T. L. Moua was convicted by a military judge of false official statement, assault consummated by a battery, disorderly conduct, and drunk and disorderly conduct. The military judge sentenced the accused to 135 days confinement, reduction to E-1, reprimand, and forfeiture of \$1,092.00. Pursuant to a pre-trial agreement, the convening authority agreed to reduce confinement by two weeks and suspend forfeitures in excess of four months.
5/2/2018	7th ESB, 1st MLG	At a Special Court-Martial at Camp Pendleton, California, Corporal R. B. Sawyer was convicted by a military judge of failure to obey a general order and wrongful use of a controlled substance. The military judge sentenced the accused to reduction to E-1, 8 months confinement, and a bad conduct discharge. Pursuant to a pretrial agreement, the convening authority agreed to suspend all confinement in excess of 180 days.
5/4/2018	Marine Corps Systems Command	At a General Court-Martial at Marine Corps Base Quantico, Virginia, a military judge convicted Gunnery Sergeant G. S. Simpson, consistent with his pleas, of conspiracy to commit an indecent visual recording, indecent visual recording, distribution of an indecent visual recording, and assault consummated by battery. The military judge sentenced the accused to a bad-conduct discharge, reduction to E-1, and 32 months confinement. In a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 18 months.

5/4/2018	HqBtry, 11th Marines	At a General Court-Martial at Camp Pendleton, California, Corporal L. T. Borgelt was convicted by a military judge of reckless driving, wrongful possession of a controlled substance, and introduction of a controlled substance. The military judge sentenced the accused to reduction to E-1, 36 months confinement, and a bad conduct discharge. Pursuant to a pretrial agreement, the convening authority agreed to suspend all confinement in excess of 12 months.
5/4/2018	H&HS Bn	At a Special Court-Martial at Camp Pendleton, California, Private First Class F. Avalosnava was convicted by a military judge of unauthorized absence. The military judge sentenced the accused to reduction to E-1, 45 days confinement, and a bad conduct discharge.
5/9/2018	FMTB-E, TrngCmd	At a General Court-Martial at Camp Lejeune, North Carolina, Petty Officer First Class A. J. Fair was convicted by a military judge of conspiracy to wrongfully sell or dispose of military property, larceny, and wrongful sale or disposition of military property. The military judge sentenced the accused to 11 months confinement, reduction to E-1, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.
5/10/2018	2dCEB, 2dMarDiv	At a General Court-Martial at Camp Lejeune, North Carolina, Corporal T. J. Dwyer was convicted by a military judge of false official statement, housebreaking, conspiracy to commit larceny, and larceny of military property. The military judge sentenced the accused to 30 months confinement, a \$8,000.00 fine, reduction to E-1, and a bad-conduct discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 19 months.
5/10/2018	VMU-2, MAG-14, 2dMAW	At a General Court-Martial at Cherry Point, North Carolina, Staff Sergeant N. S. Barclay was convicted by a military judge of failure to obey regulation, maltreatment, and sexual assault. The military judge sentenced the accused to 8 years confinement, reduction to E-1, and a dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 24 months.

5/11/2018	VMFA-251(UDP), MAG-12, 1st MAW	At a General Court-Martial in Okinawa, Japan, Corporal S. Gonzalezsoto was convicted by a military judge of attempted sexual abuse of a child. The military judge sentenced the accused to reduction to E-1, reprimand, total forfeitures, bad conduct discharge, and 30 months confinement. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 18 months.
5/11/2018	MALS-36, 1st MAW	At a General Court-Martial in Okinawa, Japan, Sergeant R. Rodriguez was convicted by a military judge of possession of child pornography and viewing of child pornography. The military judge sentenced the accused to 5 years confinement, reduction to E-1, reprimand, total forfeitures of all pay and allowances, and dishonorable discharge. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 30 months.
5/11/2018	MHHS-772, MAG- 49, 4th MAW	At a General Court-Martial at Marine Corps Support Facility, New Orleans, LA, a sergeant was acquitted by a panel of officer and enlisted members.
5/14/2018	3d TSB, 3d MLG	At a General Court-Martial in Okinawa, Japan, Lance Corporal J. C. Kindel was convicted by a military judge of conspiracy to distribute Schedule I drug, failure to obey a general order, wrongful possession of a controlled substance with the intent to distribute, wrongful distribution of a controlled substance, and wrongful use of a controlled substance. The military judge sentenced the accused to 5 years confinement, reduction to E-1, reprimand, dishonorable discharge, and total forfeiture of all pay and allowances. Pursuant to a pre-trial agreement, the convening authority agreed to suspend all confinement in excess of 16 months.
5/16/2018	MCD, Ft. Leonard Wood, MO, TRNGCMD	At a Special Court-Martial at Marine Corps Base Quantico, Corporal C. R. Woodberry was convicted by a military judge of failure to obey a lawful general order. The military judge sentenced the accused to reduction to E-2, 14 days of hard labor without confinement, and a letter of reprimand.

The military judge sentenced the accused to 198 days confinement, reduction to E-1, and a bad-conduct discharge. The pre-trial agreement had no effect on the sentence.

Pursuant to a pretrial agreement, the convening authority agreed to suspend all confinement in excess of 38 years.
