JAPAN'S ATTITUDE IN MATTER OF AMERICAN RIGHT TO REIMBURSEMENT FOR EX-PENSE OF AMERICAN FORCES IN GERMANY.

J 8103 - Japan has received memorandum from the French Government requesting their view in this matter. Japanese Ambassador in Paris points out that France failed to support Japan in regard to mandate question and recommends that Japan give France no support against the United States.

JAPANESE SECRET SERVICE.

- J 7167 Tokio reports secret examination of cablegram to the Public Ledger on the subject of Porth Saghalien.
- J 7995 Japanese Ambassador in Washington reports expiration of contract with Secret Agent Moore.
- J 8025 Tokio cables money for expenses of Secret Agent Moore.
- J 7996 Japanese Ambassador in Washington reports expiration of contract of Secret Agent McGrue and requests #2,000.00 for his salary for February and March.
- J 8246 Tokio advises of difficulty with Secret Agent Gallagher whose services have become unsatisfactory but who they are afraid to discharge for fear of making an enemy of him.
- J 7274 Japanese Ambassador recommends special consideration for a man names Steep, on the ground that he has a good position with the Tribune Bureau and that any favors shown him now will "be convenient for manipulating him in future."
- J 7994 Japanese Ambassador in Washington requests \$8,000.00 for WEnlightenment Fund."
- J 8178 Japanese Ambassador in Washington gives itemized statement of use to which he will put \$8,000.00 in "Enlightenment Fund." Attention is invited to the fact that this \$8,000.00 does not include pay for Secret Agents mentioned above.

DAIREN CONFERENCE.

J 8205 - Circular No. 100 from Tokio gives Japanese view of the Dairen Conference. Demands of the Chita Government and the views of Tokio with regard to them are shown.

- J 7828 Tokio gives recent history of the Dairen Conference.
- J 7626 Tokic assures Chita Representative that Japan will do nothing to prevent the attainment by Chita of political supremacy in Vladivostok but refuses permission for Chita troops to use the railroad controlled by Japan.
- J 7501 Circular No. 59 from Tokio discusses the demands of the Chita Government in regard to provisions in the proposed treaty relative to Anti-Communistic principles. The right of Japanese residents in the territory of the Far Eastern Republic. The question of fisheries and the right to navigate Amur and Shooks Rivers.
- J 8117 Tokic advises of the retreat of the White Army to Iman and states that the Chita Government is in financial stress but is taking full advantage of its recent victory and is pursuing the White Army step by step. Notes that the position of the Vladivostok Government is becoming a very dangerous one.

ANTI-JAPANESE PROPAGANDA ISSUED BY THE CHITA GOVERNMENT.

- J 7310 Tokio advises that the Chita Government has been warned that serious results will be produced unless the circulation of false rumors is discontinued.
- J 5961 Japanese Ambassador in Washington reports that American newspapers have published a cablegram received by representatives of the War Eastern Republic that the Japanese Army has occupied Tsitsihar, a station on the Chinese railroad.
- J 7006 Tokio advises that the above report in untrue.
- J 8088 Japanese Ambassador in Washington complains about the propaganda being circulated by Chita Representatives. Recommends the effect be offset by publication of the results of the Dairen Conference.
- J 8112 Tokic replies to the above with information that the time has not yet come for the publishing the results of the Dairen Conference but that a strong protest will be made to the Chita Government about the circulation of propaganda.

RECOGNITION OF THE SOVIET GOVERNMENT.

J 7071 - Tokio announces policy of the Japanese Government in the matter of recognition of the Soviet Government.
