The unnamed irrigation ditches on the property are man-made water features. Many of the ditches clearly follow property lines, flowing east-west or north-south. There is no evidence that the ditches were constructed in or are a relocated tributary. The ditches are not present on USGS maps
A Drain	1,502	linear feet	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	A Drain is a man-made drain (ditch), likely developed in the early 1900's to assist reducing irrigation saturation in the surrounding agricultural landscape (a characteristic of the region). There is no evidence that A Drain was constructed in or is a relocated tributary.

- B. Typical year assessment(s):** [A typical year assessment was not required to assess the jurisdictional status of the features.](#)
- C. Additional comments to support AJD:** [Aquatic features within the property appear to be exclusively resulting from constructed features in support agricultural practices. The basin size upstream of the assessment area is approxialty 448 acres \(0.7 sq. miles\), and there is no historical evidence that the features relocated or were constructed in natural tributaries. Furthermore, regional charictaristics of irrigation development by USBR and irrigation districts indicate that A Drain was constructed outside of natural aquatic resources in the ealy 1900s to drain excess irrigation water. Review of the USFWS Online NWI did not identify other aquatic features within the property, and soils units within the assessment area are classified as non-hydric \(depth to water table estimated at over 80 inches\). It is determined that the identified aquatic resources are man-made ditches which are exluded features.](#)
