3 Nov 20	8thMarReg, 2dMarDiv	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal S. A. Pels, pursuant to the accused's pleas, of violating lawful general orders and distributing a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 4 months of confinement, reduction to E-1, and a bad conduct discharge.
4 Nov 20	2dMarDiv	At a general court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal T. M. Miller, pursuant to the accused's pleas, of distribution and possession of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 18 months of confinement, reduction to E-1, and a bad conduct discharge.
5 Nov 20	2dMarDiv	At a general court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal L. H. Pollard, pursuant to the accused's pleas, of failure to obey lawful orders, making false official statements, use and possession of a controlled substance, domestic violence, and obstruction of justice. Consistent with the plea agreement, the military judge sentenced the accused to 20 months of confinement, reduction to E-1, and a bad conduct discharge.
5 Nov 20	2dMarDiv	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal N. Q. Krems, pursuant to the accused's plea, of possession of a controlled substance with intent to distribute. Consistent with the plea agreement, the military judge sentenced the accused to 9 months of confinement, reduction to E-1, and a bad conduct discharge.
6 Nov 20	III MEF	At a general court-martial at Marine Corps Base Camp Lejeune, a panel of members acquitted a Marine of all charges and specifications.
9 Nov 20	1stBn, 8thMarReg, 2dMarDiv	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Sergeant Q. N. Emery, pursuant to the accused's pleas, of wrongful use or possession of a false military pass with intent to deceive, possession of a controlled

		substance, and use of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 6 months of confinement, reduction to E-1, and a bad conduct discharge.
9 Nov 20	3dAABn, 1stMarDiv	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Gunnery Sergeant R. Reyes Jr., pursuant to the accused's pleas, of soliciting the commission of an offense and use of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 30 days of confinement, reduction to E-6, and forfeiture of \$400.00 pay for 1 month.
10 Nov 20	3dBn, 8thMarReg, 2dMarDiv	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal R. D. Scott Jr., pursuant to the accused's pleas, of distributing of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 9 months of confinement, reduction to E-1, and a bad conduct discharge.
12 Nov 20	MCRD Parris Island	At a special court-martial at Marine Corps Recruit Depot Parris Island, a military judge convicted Gunnery Sergeant E. M. Henderson, pursuant to the accused's pleas, of indecent recording, attempted indecent recording, and making a false official statement. Consistent with the plea agreement, the military judge sentenced the accused to 6 months of confinement, reduction to E-1, forfeiture of 2/3 pay per month for 2 months, and a bad conduct discharge.
17 Nov 20	3dBn, 8thMarReg, 2dMarDiv	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Corporal D. A. Williams, pursuant to the accused's pleas, of possession of a controlled substance, obstructing justice, receiving or concealing stolen property of a value of more than \$1,000, and conspiracy. Consistent with the plea agreement, the military judge sentenced the accused to 2 months of confinement, reduction to E-1, and a bad conduct discharge.

17 Nov 20	1stMLG	At a general court-martial at Marine Corps Air Ground Combat Center Twentynine Palms, a military judge convicted Lance Corporal D. A. Beltz, pursuant to the accused's pleas, of attempted larceny of non-military property and larceny of non-military property. Consistent with the plea agreement, the military judge sentenced the accused to 16 months of confinement, reduction to E-1, total forfeiture of all pay and allowances, and a bad conduct discharge.
17 Nov 20	2dMAW	At a general court-martial at Marine Corps Air Station New River, a military judge acquitted a Marine of all charges and specifications.
18 Nov 20	1stMarDiv	At a general court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal J. T. Sweezer, pursuant to the accused's pleas, of aggravated assault. Consistent with the plea agreement, the military judge sentenced the accused to 12 months of confinement, reduction to E-1, total forfeiture of all pay and allowances, and a bad conduct discharge.
18 Nov 20	3dRTBn	At a special court-martial at Marine Corps Recruit Depot San Diego, a military judge convicted Private First Class O. M. Davila Jr., pursuant to the accused's pleas, of wrongful appropriation and unauthorized absence. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1.
19 Nov 20	1stMaintBn, 1stMLG	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal D. L. Smith, pursuant to the accused's pleas, of communicating threats, assault upon a sentinel, aggravated assault, assault upon a non-commissioned officer, assault consummated by battery, and drunk and disorderly conduct. Consistent with the plea agreement, the military judge sentenced the accused to 90 days of confinement, reduction to E-1, a \$2,300 fine, and a bad conduct discharge.
20 Nov 20	3dMarReg, 3dMarDiv	At a special court-martial at Marine Corps Base Hawaii, a military judge convicted Corporal B. Durigon III, pursuant to the accused's pleas, of assault consummated by a battery. Consistent with the plea agreement, the military judge sentenced the accused to 3 months of confinement and reduction to E-1.

20 Nov 20	MCIPAC	At a general court-martial at Marine Corps Base Camp Lejeune, a panel of members acquitted a Marine of all charges and specifications.
20 Nov 20	1stLARBn, 1stMarDiv	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal B. W. Chatham, pursuant to the accused's pleas, of conspiracy to distribute a controlled substance and distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 7 months of confinement, reduction to E-1, forfeiture of \$1,000 pay per month for 12 months, and a bad conduct discharge.
23 Nov 20	CLR-17, 1stMLG	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal D. D. Jenkins, pursuant to the accused's pleas, of unauthorized absence and transporting illegal aliens. Consistent with the plea agreement, the military judge sentenced the accused to 182 days of confinement, reduction to E-1, and a bad conduct discharge.
23 Nov 20	2dMAW	At a special court-martial at Marine Corps Air Station Cherry Point, a military judge convicted Lance Corporal J. D. Johnson, pursuant to the accused's pleas, of distributing a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to 10 months of confinement, reduction to E-1, forfeiture of 2/3 pay per month for 12 months, and a bad conduct discharge.
23 Nov 20	MWSS-272	At a special court-martial at Marine Corps Air Station Cherry Point, a military judge convicted Corporal R. R. O'Donnell of use of a controlled substance. The military judge sentenced the accused to reduction to E-3.
