4/1/2020	MARFORCOM	At a General Court-Martial at Marine Corps Recruit Depot Parris Island, a military judge convicted Corporal S. G. Price, consistent with his pleas, of failure to obey a lawful written order, drunk driving, communicating a threat, provoking speeches or gestures, and assault upon a law enforcement officer. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1.
4/2/2020	HMHT-302 MAG- 29 2d MAW	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal M. C. SerranoLopez, consistent with his pleas, of wrongful use, possession, and distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to a bad-conduct discharge, reduction to E-1, and 180 days confinement (i.e. the following concurrent terms: 60 days confinement for the possession, 180 days confinement for the distribution, and 45 days for the use).
4/3/2020	Hq Spt Bn SOI-E Trng Cmd	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Private First Class I. A. Montigue, consistent with his pleas, of knowingly using a credit or debit card without authorization. Consistent with the plea agreement, the military judge sentenced the accused to 160 days confinement, forfeiture of \$1000 per month for four months, reduction to E-1, and a bad-conduct discharge.
4/3/2020	2d Bn 10th Mar Regt 2d MARDIV	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Corporal M. Tyrone, Jr., consistent with his pleas, of unauthorized absence, violation of a lawful general order, and communicating a threat. Consistent with the plea agreement, the military judge sentenced the accused to a bad-conduct discharge, reduction to E-1, and 6 months confinement (i.e. the following concurrent terms: 1 month for a specification of unauthorized absence, 1 month for violation of a lawful general order, 2 months for a second violation of a lawful general order, and 6 months each for two specifications of communicating a threat).

4/6/2020	MASS-2 MACG-18 1ST MAW	At a Special Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a military judge convicted Corporal B. Muzila, consistent with his pleas, of making a false official statement and indecent conduct. The military judge sentenced the accused to 120 days confinement, reduction to E-1, and a bad-conduct discharge. Pursuant to the pretrial agreement, the convening authority will suspend the punitive discharge for a period of 6 months.
4/8/2020	1st Bn 3d Mar Regt 3d MARDIV	At a Special Court-Martial at Marine Corps Base Hawaii, a military judge convicted Lance Corporal A. M. Selick, pursuant to his pleas, of violation of a lawful general order; False official statement; and wrongful use, possession, and distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to forfeiture of \$1,100 pay per month for 3 months, reduction to E-1, a bad-conduct discharge, and 90 days confinement (i.e. the following concurrent terms: 75 days for violating the lawful general order, 50 days for making a false official statement, 60 days for a specification of use of controlled substance, 50 days for a second specification of use, 50 days for possession of a controlled substance, and 90 days for distributing a controlled substance).
4/8/2020	8th Comm. Bn 2d MLG	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Gunnery Sergeant C. M. Whitehead, consistent with his pleas, of an unauthorized absence, breaking restriction, violation of a lawful general order, and uttering worthless checks. The military judge sentenced the accused to 10 months confinement, reduction to E-1, and a bad-conduct discharge. The pretrial agreement had no effect on the adjudged punishment

4/8/2020	III MEF	At a General Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a military judge convicted Lance Corporal J. Macko, consistent with his pleas, of attempted sexual abuse of a child; attempted conspiracy to rape a child; sexual abuse of a child; and production and possession of child pornography. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1, a dishonorable discharge, and 96 months confinement (i.e. a 24 month term of confinement for attempted sexual abuse that runs concurrent with a 48 months term for attempted conspiracy to rape a child. These two concurrent terms will run consecutive to another group of concurrent terms consisting of a 24 months term for sexual abuse of a child, a 48 month term for production of child pornography, and a 36 month term for possession of child pornography).
4/9/2020	HMHT-302 MAG-29 2d MAW	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Sergeant T. C. Joseph, consistent with his pleas, of wrongful use and possession of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1, a bad-conduct discharge, and 105 days confinement (i.e. the following concurrent terms: 45 days confinement for use of a controlled substance, 105 days for a specification of possession, and 90 days for a second specification of possession).
4/9/2020	VMFA-122 MAG-13 3d MAW	At a Special Court-Martial at Marine Corps Air Station Yuma, a military judge convicted Lance Corporal Z. D. Sommer, consistent with his pleas, of unauthorized absence, failure to obey a lawful general order, making a false official statement, and larceny of non-government property. The military judge sentenced the accused to reduction to E-1, a bad-conduct discharge, and 6 months confinement (i.e. the following concurrent terms: 1 month confinement for unauthorized absence, 5 months for a specification of failure to obey a lawful general order, 3 months for a second failure to obey a lawful general order, 4 months for making a false official statement, and 6 months each for three specifications of larceny).

4/14/2020	MAG-12 1st MAW	At a Special Court-Martial at Marine Corps Air Station Iwakuni, a military judge convicted Staff Sergeant F. Gonzales, consistent with his pleas, of violation of a lawful general order. The military judge sentenced the accused to 30 days restriction, reduction to E-5, and a written reprimand. The pretrial agreement in this case had no effect on the sentence.
4/14/2020	2d MARDIV	At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Sergeant J. Correa, consistent with his pleas, of possession of a controlled substance, possession of a controlled substance with intent to distribute, and introduction of a controlled substance with intent to distribute. Consistent with the plea agreement, the military judge sentenced the accused to a \$3000.00 fine (i.e. a \$1,000 fine for the specification of introduction, and each of the specifications of possession with intent to distribute), reduction to E-1, a dishonorable discharge, and 30 months confinement (i.e. the following concurrent terms: 20 months for introduction of controlled substance, 25 months for a specification of possession with intent to distribute, 30 months for a second specification of possession with intent to distribute, 20 months for a specification of possession, and 30 months for a second specification of possession).
4/15/2020	3d Mar Regt 3d MARDIV	At a Special Court-Martial at Marine Corps Base Hawaii, a military judge acquitted a corporal of failure to obey lawful general order.
4/16/2020	1st Bn 10th Mar Regt 2d MARDIV	At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal A. A. Ortiz, consistent with his pleas, of violation of a lawful written order, aggravated assault by strangulation, and assault consummated by a battery. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1, a bad-conduct discharge, and 8 months confinement (i.e. the following concurrent terms: 1 month for violation of a lawful written order, 6 months for aggravated assault by strangulation, 2 months for assault consummated by a battery, and 6 months for a second specification of aggravated assault by strangulation).

4/16/2020	2d MAW	At a General Court-Martial at Marine Corps Air Station New River, North Carolina, a military judge convicted Lance Corporal B. Vinasco, consistent with his pleas, of possession of a controlled substance with intent to distribute, and distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to total forfeitures, reduction to E-1, a bad-conduct discharge, and 18 months confinement (i.e. four concurrent terms of 18 months confinement, one for possession of a controlled substance with intent to distribute and one for each of the three specifications of distribution).
4/21/2020	MACS-1 MWSG-38 3d MAW	At a Special Court-Martial at Marine Corps Air Station Yuma, a military judge convicted Lance Corporal D. J. Bramlette, consistent with his pleas, of assault consummated by a battery, aggravated assault by strangulation, and obstructing justice. Consistent with the plea agreement, the military judge sentenced the accused to a bad-conduct discharge, and 12 months confinement (i.e. the following concurrent terms: a 6 month term for each of the two specifications of assault consummated by a battery, 12 months for aggravated assault by strangulation, and 9 months for obstructing justice).
4/23/2020	9th Comm Bn, I MIG I MEF	At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal A. R. Kellett, consistent with his pleas, of attempted distribution of a controlled substance, conspiracy to distribute a controlled substance, and introduction and distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused forfeiture of \$1,155.00 per month for 4 months, reduction to E-1, a bad-conduct discharge, and 100 days confinement (i.e. the following concurrent terms: 100 days for the attempted distribution, 100 days for the conspiracy to distribute, and a 100 day term each for four specifications of introduction and distribution of a controlled substance).
4/24/2020	MCESG	At a General Court-Martial at Marine Corps Base Quantico, a military judge convicted Lance Corporal C. T. Tessier, consistent with his pleas, of extortion. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1, 6 months confinement, and a bad-conduct discharge.
