SUBJECT: Evaluation of DoD Medical Treatment Facility Challenges During the Coronavirus Disease 2019 (COVID-19) (Project No. D2020-DEV0PB-0136.000)

We plan to begin the subject evaluation in May 2020. The objective of this evaluation is to determine the challenges and needs DoD medical treatment facilities (MTFs) encounter in responding to the COVID-19 pandemic. We may revise the objective as the evaluation proceeds, and we will also consider suggestions from management for additional or revised objectives.

We will perform the evaluation at the Defense Health Agency and selected MTFs as identified in the Attachment. We may identify additional MTFs to include during the evaluation. Due to the current Health Protection Condition level, we will hold meetings by teleconference.

Please provide us with a point of contact for the evaluation within **5 days** of the date of this memorandum. The point of contact should be a Government employee—a GS-15, pay band equivalent, or the military equivalent. In addition, to expedite information gathering and reporting, please provide us with a point of contact for each of the MTFs listed in the Attachment within **7 days** of the date of this memorandum. The point of contact should be an MTF commander, administrator, or other contact who can adequately speak to the MTF's needs and challenges in responding to COVID-19.
