| 1/7/2020 | TRNG CMD | At a General Court-Martial at Marine Corps Recruit Depot San Diego, a military judge convicted Sergeant S. R. Wilson II, consistent with his pleas, of sexual assault of a child, sexual abuse of a child, enticing a minor, and obstruction of justice. The military judge sentenced the accused to 36 months confinement, reduction to E-1, forfeiture of all pay and allowance, and a dishonorable discharge. Pursuant to the plea agreement, the convening authority will suspend all confinement in excess of 27 months. |
| 1/6/2020 | 2d MAW | At a General Court-Martial at MCRD Parris Island, a military judge convicted Corporal S. T. Daily, consistent with his pleas, of involuntary manslaughter, willful discharge of a firearm, and violation of a lawful general order. Consistent with the plea agreement, the military judge sentenced the accused to forfeiture of all pay and allowances, reduction to E-1, a dishonorable discharge, and 69 months confinement (comprised of a 69 month term for involuntary manslaughter, a 12 month term for willful discharge of a firearm, and a 12 month term for violating a lawful general order all running concurrently). |
| 1/8/2020 | MALS-36 MAG 36 1st MAW | At a Special Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a panel of officer and enlisted members convicted Sergeant B. J. McPherson of reckless driving. The members sentenced the accused to reduction to E-3. |
| 1/9/2020 | H&HS MCAS Yuma | At a General Court-Martial at Marine Corps Air Station Yuma, a military judge convicted Corporal T. A. Page III, consistent with his pleas, of wrongful broadcasting or distributing intimate images and abusive sexual contact. Consistent with the plea agreement, the military judge sentenced the accused to 6 months confinement (consisting of a 6 month term for wrongful broadcast or distribution of intimate images and a 6 month term for abusive sexual contact running concurrently), reduction to E-1, forfeiture of all pay and allowances, and a bad-conduct discharge. |

| 1/10/2020 | 1st MARDIV | At a General Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Sergeant J. T. Matthews, consistent with his pleas, of aggravated assault upon a child. In accordance with the plea agreement, the military judge sentenced the accused to 6 months confinement and reduction to E-1. |
| 1/11/2020 | MCESG | At a Special Court-Martial at Marine Corps Base Quantico, a panel of officer and enlisted members convicted Lance Corporal F. A. Twillman of larceny. The members sentenced the accused to 60 days restriction and reduction to E-1. |
| 1/13/2020 | 2d MARDIV | At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Sergeant A. Martinez, consistent with his pleas, of three attempts to sexually abuse of a child. Consistent with a plea agreement, the military judge sentenced the accused to 17 months confinement (consisting of consecutive 8 and 9 month terms for the first two attempts, and a concurrent 1 month term for the final attempt), reduction to E-1, and a dishonorable discharge. |
| 1/14/2020 | 3d MAW | At a General Court-Martial at Marine Corps Air Station Miramar, a military judge convicted Petty Officer Second Class M. P. Land, consistent with his pleas, of two attempts to sexually abuse a child. Consistent with the plea agreement, the military judge sentenced the accused to 14 months confinement (comprised of a 12 and 14 month term for the two attempts, running concurrently), reduction to E-1, and a dishonorable discharge. |
| 1/14/2020 | 1st MARDIV | At a General Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal B. D. Law II of unlawfully transporting, for private financial gain, aliens who entered the United States illegally and wrongful use and distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, forfeiture of all pay and allowance, reduction to E-1, and 18 months confinement (comprised of an 18 month term for each of six violations of law prohibiting transport of aliens who entered illegally, two 18 month terms for distributing controlled substances, and two 12 month terms for use of controlled substances all terms running concurrently). |

| 1/14/2020 | 3d MLG | At a General Court-Martial at Marine Corps Base Kaneohe Bay, Hawaii, a military judge convicted Private First Class A. J. Alkazahg of fraudulent enlistment, false official statements, and possession of a machine gun in violation of federal law. In accordance with a plea agreement, the military judge sentenced the accused to a bad-conduct discharge, total forfeiture of all pay and allowances, reduction to E-1, and 36 months confinement (comprised of a 24 month term for fraudulent enlistment, a 24 month term for each for two false official statements, and a 36 month term for each for two violations of federal law all running concurrently). |
| 1/15/2020 | H&HS MCAS Futenma | At a Special Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a military judge convicted Lance Corporal R. B. Surge, consistent with his pleas, of Article knowingly using a stolen credit card or debit card. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1. |
| 1/15/2020 | 2d MARDIV | At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal M. I. Smith, consistent with his pleas, of extramarital sexual conduct and sexual assault. In accordance with the plea agreement, a military judge sentenced the accused to a dishonorable discharge, reduction to E-1, and 18 months confinement (comprised of a 12 month term for each of two incidents of extramarital sexual conduct and an 18 month term for each of two incidents of sexual assault all running concurrently). |
| 1/15/2020 | 1st Bn, 5th Mar Regt | At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Sergeant K. L. Rowan, consistent with his pleas, of adultery. The military judge sentenced the accused to 90 days hard labor without confinement, a reprimand, and reduction to E-4. The plea agreement had no effect on the sentence. |
| 1/16/2020 | H&HS MCAS Futenma | At a Special Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a military judge convicted Private First Class A. J. Manigault, consistent with his pleas, of knowingly using a stolen credit or debit card. In accordance with the plea agreement, the military judge sentenced the accused to 63 days confinement, reduction to E-1, and a bad-conduct discharge. |

| 1/16/2020 | 2d Supp Bn CLR 25 2d MLG | At a Special Court-Martial at Camp Lejeune, North Carolina, a panel of officer and enlisted members acquitted a Sergeant of violations of a lawful general order. |
| 1/17/2020 | 2d Force Storage Bn, MCLB Albany | At a Special Court-Martial at MCRD Parris Island, South Carolina a panel of officer and enlisted members acquitted a Sergeant of making a fraudulent claim, making a false and fraudulent writing, false official statements, and larceny. |
| 1/23/2020 | IT Bn SOI-W TRNG CMD | At a Special Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Sergeant J. M. Dodd of failure to obey a lawful order. The military judge sentenced the accused to 10 days confinement, 30 days restriction, and reduction to E-4. |
| 1/24/2020 | 3d MARDIV | At a General Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a military judge convicted First Sergeant F. M. Ramos, consistent with his pleas, of larceny of military property and signing false documents. The military judge sentenced the accused to 89 days confinement and reduction to E-5. In accordance with the pretrial agreement, the convening authority will disapprove the confinement. |
| 1/24/2020 | H&S Bn SOI-E TRNG CMD | At a Special Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Private First Class C. L. Littlefield, consistent with his pleas, of assault consummated by a battery. The military judge sentenced the accused to 60 days confinement, reduction to E-1, and a bad-conduct discharge. |
| 1/27/2020 | 2d Recruit Trng Bn, RTR, MCRD PI | At a Special Court-Martial at MCRD Parris Island, South Carolina a military judge convicted Sergeant C. L. Traylor, consistent with his pleas, of larceny. The military judge sentenced the accused to reduction to E-3. In accordance with the pretrial agreement, all adjudged punishment will be disapproved. |
| 1/28/2020 | 1st MAW | At a General Court-Martial at Marine Corps Base Camp Foster, Okinawa, Japan, a military judge convicted Gunnery Sergeant R. S. Harry, consistent with his pleas, of larceny. In accordance with a plea agreement, the military judge sentenced the accused to reduction to E-6, total forfeiture of all pay and allowances, and 60 days confinement (comprised of a 60 day term each for three violations of larceny and a 14 day term for a fourth violation all running concurrently). |

| 1/29/2020 | MARSOC | At a General Court-Martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal C. J. Brown, consistent with his pleas, of aggravated assault upon a child. The military judge sentenced the accused to 50 months confinement, reduction to E-1, and a bad-conduct discharge. Pursuant to a pretrial agreement, the convening authority will suspend all confinement in excess of 36 months. |
| 1/29/2020 | MWSS 374 MWSG 37 3D MAW | At a Special Court-Martial at Marine Corps Air Ground Combat Center Twentynine Palms, a military judge convicted Staff Sergeant A. Pena, consistent with his pleas, of unauthorized absence and wrongful use of a controlled substance. The military judge sentenced the accused to 60 days restriction and reduction to E-3. There was no plea agreement. |
| 1/30/2020 | 2d Force Storage Bn, MCLB Albany | At a Special Court-Martial at MCRD Parris Island, South Carolina, a panel of officer and enlisted members convicted Staff Sergeant, N. D. Hardy of making a false writing, making a false or fraudulent claim, and larceny. The members sentenced the accused to reduction to E-5. |
| 1/30/2020 | 1st MARDIV | At a General Court-Martial at Marine Corps Base Camp Pendleton, a panel of officer and enlisted members acquitted a Lance Corporal of sexual assault. |
| 1/31/2020 | 2d Bn 10th Mar Regt 2d MARDIV | At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Lance Corporal Q. D. Mclaughlin, consistent with his pleas, of conspiracy and obtaining services under false pretenses. The military judge sentenced the accused to 150 days confinement, a \$3,000 fine, reduction to E-1, and a bad conduct discharge. Pursuant to a plea agreement, the convening authority will suspend all confinement in excess of the amount the accused served in pretrial confinement (136 days). |
| 1/31/2020 | 2d MLG | At a General Court-Martial at Camp Lejeune, North Carolina, a military judge convicted Sergeant J. A. Huntley, consistent with his pleas, of possessing, receiving, or viewing child pornography and distributing child pornography. The military judge sentenced the accused to 36 months confinement, reduction to E-1, and a DD discharge. The pretrial agreement had not effect on the execution of the adjudged punishment. |
