- B. Typical year assessment(s):** A typical year assessment was not required to assess the jurisdictional status of the features.
- C. Additional comments to support AJD:** The Central Ditch is a man-made irrigation feature that was not constructed in a natural tributary, nor does it relocate a natural tributary. The alignment of the feature is straight and consistent. The surrounding area is a joint National Guard base, Boise International Airport, public BLM lands, Boise City lands, and residential developments. Hydrology is limited to irrigation water received from Fivemile Creek. Therefore the Central Ditch is not considered a water of the U.S.
