When must information be submitted to the Coast Guard?	One of the forms must be submitted anytime a private aid to navigation is established, modified, moved, removed or ownership is changed.	
How is the information submitted?	One of the two forms is submitted In writing to the Coast Guard district where the private aid to navigation will be placed. The First Coast Guard District utilizes a website for submissions.	
What happens when information is received?	The Coast Guard district evaluates the application and notifies the applicant of its approval or disapproval. If approved, the district prepares a Notice to Mariner to inform the maritime public of the type, color, and geographic position of the private aid to navigation.
