The unnamed local user ditches are man-made irrigation features limited in length, that flows from south to north and conveys stormwater and irrigation runoff. They do not follow topographic drainages and are not present on USGS maps. There is no evidence that they were constructed in, or are a relocated (a)(2) tributary.

C. Additional comments to support AJD: [The Calkins Lateral and the unnamed local user ditches are aquatic features created for the purpose of irrigation conveyance. There is no evidence that the aquatic features were constructed in a natural tributary, nor is there evidence that they relocate a natural tributary. The Calkins Lateral was constructed in 1908 by J.A. Flood as an extension of the Boise Project through Ada County. The land surrounding the project area consists of both upland agricultural lands and residential developments. Hydrology is limited to irrigation water received from the Rawson Canal, stormwater runoff, and irrigation runoff. The USFWS NWI map shows no jurisdictional wetlands within the review area.](#)
