(1945)

Your No. 107[a].

1. [OK We agree] to "ARTUR's"[i] entering CHILE to get his papers[DOKUMENTY] in order.
2. Issue "ARTUR" with money to pay for the journeys[b] and the papers and see to it that he has an adequate sum for organising cover and a three months' advance of salary.
3. It is desirable that "ARTUR" should [7 groups unrecovered] from CHILE to RIO[ii]
[9 groups unrecovered]
cover for RIO from him in CHILE.

12. We agree to "LUIZA's" being paid a subsistence allowance - up to the moment when she departs for RIO - of 75-dollars a month.

13. We categorically forbid "ARTUR" to make use of secret writing as a means of communication.

Comments: [i] ARTUR: Unidentified covername. Also occurs in messages between 15th May 1942 and 26th December 1944 on the NEW YORK-MOSCOW link and between 23rd June 1944 and 10th July 1945 on the MONTEVIDEO-MOSCOW link.

[ii] RIO: Presumably RIO DE JANEIRO.

[iii] LUIZA: Unidentified covername. Also occurs in MOSCOW to MONTEVIDEO Nos. 72 of 27th February 1945 (3/NBF/T1400) and 197 of 21st June 1945 (3/NBF/T698).

[iv] VIKTOR: Lt. Gen. P.M. FITIN.
