SECTION ONE - HIGHLIGHTSWQH EV SAM AC MULTICHANNEL COMMUNICATIONS IN THE  
DRVH REVEALED THAT ON 31 OCTOBER 65 TWO SURFACE TO AIR MISSILES WERE LA AT WEQ  
OT DESTROY AT TARGET TWENTY-FIVE KILOMETERS (13.5 NAUTICAL MILES) AWAY. NO  
RESULTS OF THESE LAUNCHES WERE REPORTED. THE SAM INSTALLATION WAS DETERMINED TO  
BE LOCATED AT 2130N/10606E. COMMENT: AAA COMMUNICATIONS F INSTALLATION  
LOCATED AT/NEAR THE SAM INSTALLATION REPORTED IT HAD DESTROYED A TARGET AT 0235.  
THE TARGET AT THAT TIME LOCATED BTWN 2102N/10604E AND 2113N/10616E. 2. DRV MIG  
SHOOT DOWN MULTICHANNEL COMMUNICATIONS FROM M INSTALLATION LOCATED AT  
2130N/10606E AT 0330 REPORTED THAT A POSSIBLE FRIENDLY MIG HAD BEEN SHOT DOWN  
BY HAAA THIS MIG SHOOT DOWN WAS CONFIRMED ON DRV GCI FACILITIES AT 0311 WHEN AN  
UNIDENTIFIED DRV AIRCRAFT REPORTED "SHOT DOWN... HE IS FALLING. 89 HAS FALLEN TO
