The unnamed irrigation ditch is a concrete lined user ditch specifically constructed for the use within the properties. The ditches follow the existing agricultural fields. There is no evidence that these ditches were constructed in or relocated a tributary or other jurisdictional feature.		
Unnamed Irrigation Drain	3400	linear feet	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	The unnamed earthen drains are constructed drains servicing adjacent land. Two of the drains originate within or near the property, and the third flows in from the west. All three features combine and flow north to the Purdam Drain. There is no evidence that these drains were constructed in or relocated a tributary or other jurisdictional feature.

- **B.** Typical year assessment(s): A Typical Year assessment was not required to determine the jurisdiction of aquatic resources within the review area.
- **C.** Additional comments to support AJD: Aqautic resources within the review area, are limited to the Marvin Lateral, Unnamed Irrigation Ditches, and Unnamed Irrigation Drains. The properties are historically agricultural fields, and the all aquatic resources are limited to man-made constructed irrigation ditches and drains which service those uses. Review of available information determined that there is no evidence that these features are relocated tributaries, or were constructed in a tributary or other jurisdictional feature and therefore are excluded features within the review area.
