There is no evidence that the segment of the lateral within the review area was constructed in or relocated from a natural tributary. Topographic maps display no intermittent or perennial stream occurrence prior to the construction of the lateral. There is no evidence that the segment of the lateral within the review area was constructed in an adjacent wetland. A report from the USFWS Wetland Mapper does not reveal any wetlands. A soil survey shows no hydric soils and aerial imagery show that the land is used primarily for agricultural activities. The lateral is an upland constructed channel which is hydrologically connected to the Hill Canal.

- **B.** Typical year assessment(s): A typical year assessment was not necessary to assess the jurisdictional status of features within the property.
- C. Additional comments to support AJD: The property has been historically used for agricultural purposes and contains a natural drainage which provides irrigation. The USFWS online wetland mapper does not show any abutting wetlands and the lateral did not identify the C.L.E. 10.2 lateral as a wetland resource. The lateral appears to follow the same alignment as the Hill Canal. The soil units for the project were classified as Elijah-Chilcott silt loams (1 to 3 percent slopes) and Elijah-Vickery silt loams (7 to 12 percent slopes), neither of which are hydric soils. The C.L.E. 10.2 lateral is an excluded feature from the Clean Water Act.
