**C. Additional comments to support AJD:** [The 50 acre review area contains an undefined amount of wetlands. The only feature that accepts sheet flow runoff from the wetlands in the review area is a man-made storm water ditch, with multiple piped sections, connected to the wetland via a culvert under the abutting railroad tracks at the south east end of the property. The man-made storm water ditch is not a waters of the U.S. as it falls under the \(b\)\(5\) and \(b\)\(10\) exclusions, and does not meet the definition of a](#)

<sup>5</sup> Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
