- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There is an NWI intermittent stream that is mapped within the review area. There were several sampling points taken within this mapped drainage; although there were some slight drainage patterns observed through the vegetation, and the elevation is slightly lower than the surrounding landscape (valley between hillslopes), there was no obvious or defined channel present. The wetland delineation was conducted during a drought year, but it was during a time of year when runoff and hydrology should've been observed if present. The data collected and recorded on the wetland determination data forms shows that indicators of a defined channel, bed, and bank were absent in the sampling points taken in this drainage. Considering no indicators were present, the drainage would be non-jurisdictional. See wetland determination data forms in the submitted wetland delineation, submitted on July 9, 2021.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
