It does not follow topographic drainages and is not present on USGS maps. There is no evidence that it was constructed in, or is a relocated (a)(2) tributary.
Dry Creek Canal	500	linear feet	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	The Dry Creek Canal is a man-made irrigation feature. It receives water from the Boise River and historically has supplied water to local irrigation fields. There is no evidence that it was constructed in, or is a relocated (a)(2) tributary.

The alignment of the feature is straight and consistent. The surrounding area is upland agricultural lands and residential developments. Hydrology is limited to irrigation water received from the Foothills Ditch.](#)

[The Dry Creek Canal was constructed to deliver irrigation water to local agricultural fields. It does not show up on USGS maps as a natural stream, and does not appear to have been an \(a\)\(2\) tributary altered or captured to convey irrigation flows.](#)
