PLEASE TELL SULLIVAN THAT UP TO TODAY THE GVN ((GOVERNMENT OF VIETNAM)) HOLDS NO UP TO DATE TEXT OF THE PROTOCOLS AS DISCUSSED BETWEEN U.S. AND NVN ((NORTH VIETNAMESE)) EXPERTS. WE ONLY HAVE THE TEXTS AS THEY STOOD ON 12 DECEMBER. TO BE ABLE TO PUT THE FINISHING TOUCHES ON THESE TEXTS, THE GVN INSISTS THAT, AS THEY COME UP, THE U.S. GOVERNMENT COMMUNICATE THE DETAILS ON THE TEXTS OF THE PROTOCOLS. IF THE U.S. GOVERNMENT REFUSES TO SEND US THE TEXTS IN TIME AND AS THEY COME UP, THE GVN WILL NOT BE RESPONSIBLE FOR DELAYS. REGARDS
