SULLIVAN IS REMAINING ((IN PARIS)) FOR A FEW DAYS IN ORDER TO COMPLETE THE SETTLEMENT OF PARTICULAR POINTS. HAIG'S MISSION WOULD THEN PRESENT OUR GOVERNMENT WITH THE DRAFT OF THE ACCORD AS FINALLY CONCLUDED AND DEEMED "JUST AND FAIR" BY THE U.S.
