1. PER TELECON DADP AND D/CH NSAPAC 5 FEB. INITIAL INVENTORY AND DAMAGE ASSESSMENT OF SIGINT AND COMSEC MATERIALS ON PUEBLO ^{HAVE} HAS BEEN COMPLETED. PROPOSAL FOR TECHNICAL SURVEY BY NSA TEAM WOULD A) ASSIST INTERROGATORS NOT FAMILIAR WITH SPECIFIC SIGINT MATERIALS AND B) PROVIDE DETAILED FEEDBACK TO NSA TO MODIFY INITIAL DAMAGE ASSESSMENTS BASED ON INTERROGATION AND OBSERVATIONS. DESIRE DIRECT PARTICIPATION BY NSA TECHNICIANS IN DEBRIEF.

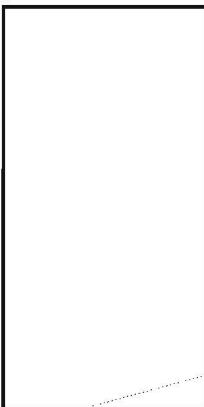

M/R: Message prepared as follow-up to HIR/34 to JCS indicating NSA intent to participate in technical survey of PUEBLO personnel and ship when available. Telephone conversation between DABP, Gen. Morrison and D/NSAPAC, Mr. Drake to coordinate efforts resulted in agreement to provide list of personnel that could be used on short notice to assist in DEBRIEF operations. Team composition has been prepared to cover all areas so that necessary administrative preparations could be accomplished. The actual team composition and participants will be tailored to needs as the situation develops and requirements become clearer. In addition, a list of specific questions is being prepared within P and by S to be forwarded to NSAPAC electrically for use by interrogators if events overtake preparation for direct NSA participation. Blanket orders and open TR's are being prepared to cover all eventualities. The team will operate as a "fly away group".
