SUBJECT: PUEBLO

Since we must anticipate several encounters between the Director/Deputy Director and Congressional committees as well as other elements, within the Executive Branch upon completion of the PUEBLO Court of Inquiry and/or any subsequent military judicial procedures, it becomes essential that we be well prepared with all available facts at our disposal and speak with one voice. Many questions will undoubtedly be raised directed toward NSA involvement.

Attached is a list of questions which have been generated in-house with regard to the PUEBLO. Some are not directly related to the mission but may surface upon development of a particular area. It is requested that you develop answers to these questions for use in arriving at a single Agency response, i.e., the real answer, albeit embarrassing in some cases, succinct, supported by fact, and which you consider would unhesitatingly be acceptable to an extremely intelligent individual possessing an inordinate amount of common sense and a basic familiarity with SIGINT.
