SIGINT REFLECTIONS OF UNIDENTIFIED VESSEL ACTIVITY OFF THE
NORTH KOREAN EAST COAST ON 22 JANUARY 1968

CLASSIFIED THE FOLLOWING SUMMARIZES SIGINT REFLECTIONS OF THE
MOVEMENT OF AN UNIDENTIFIED VESSEL OF UNIDENTIFIED
NATIONALITY OFF THE EAST COAST OF NORTH KOREA ON 22 JANUARY
1968. NO SIGINT REFLECTIONS HAVE BEEN NOTED IN NORTH KOREAN
COMMUNICATIONS PRIOR TO 220700Z WHICH CAN BE CORRELATED TO
THIS ACTIVITY.

AT APPROXIMATELY 220700Z THE NKM RADAR STATION AT
KALGOCH' I-R1 (39-19N 127-34E) BEGAN TRACKING AN UNIDENTIFIED
CLASSIFIED SHIP OF UNIDENTIFIED NATIONALITY AND PLACED HER POSITION AT
APPROXIMATELY 39-22N 128-10E. BETWEEN 220700Z AND 220730Z,

THE TRACKING REPORTS INDICATED THAT THE UNIDENTIFIED SHIP
1 MOVED SOUTH TO AN AREA BOUNDED BY APPROXIMATELY 39-19N AND
39-14N LATITUDE AND 128-04E LONGITUDE. SHE

REMAINED IN THIS AREA AND WAS TRACKED UNTIL SHE "DISAPPEARED"

UNTIL AT LEAST 221530Z.

HEADING BACK TOWARD SHORE BETWEEN 220700Z AND 220920Z AND

"DISAPPEARED" AT APPROXIMATELY 39-43N 128-05E. ALSO,
ANOTHER UNIDENTIFIED VESSEL WAS REFLECTED IN THE SAME

39-18N 128-14E AT 221235Z. FINALLY, THERE WERE NKN
TRACKINGS OF AN NKN PATROL CRAFT WHICH MOVED FROM

NO EVIDENCE THAT THE ABOVE MENTIONED UNIDENTIFIED VESSEL

WAS THE U.S.S. PUEBLO.
