Coast Guard Headquarters welcomed former Dept. of Transportation (DOT) Secretary Norman Mineta, as its keynote speaker for an Asian American and Pacific Islander (AAPI) Heritage Month Observance on May 27th. The visit represented a homecoming since, during Mineta's tenure as Secretary, DOT was the Coast Guard's executive agency. As the keynote speaker, Mineta reflected on the meaning embodied in his service as the Secretary of Transportation overseeing the Coast Guard and its workforce. "It gave me a great deal of pride to be the Secretary of the Coast Guard. I still cherish those memories of working with the uniformed service members and civilians because all of you are so dedicated to your job and this country," Mineta said. "You carry out this mission with passion and I appreciate what you all do on a daily basis," he added. During the event, Mineta also shared his story about being imprisoned by the U.S. during World War II because of his Japanese ancestry, his involvement in making AAPI Heritage Week a month-long celebration, and the people who inspired him. 
CIVIL RIGHTS AWARDS PROGRAM SOLICITATIONS

JUNETEENTH BECOMES FEDERAL HOLIDAY

On June 17th, 2021, President Joseph R. Biden signed the "Juneteenth National Independence Day Act" which recognizes Juneteenth, or June 19th, as a federal holiday. Juneteenth gives national recognition to and commemorates the day when the last enslaved African-Americans were informed that they were free. Abraham Lincoln enacted the Emancipation Proclamation in 1863, but it wasn't until two years later, on June 19th, 1865, that Maj. Gen. Gordon Granger arrived in Galveston, Texas and confirmed the freedom of the last remaining slaves. It's estimated that around 250,000 slaves were still not free in the Confederate south during these two years. Dr. Terri Dickerson, Civil Rights Director, released a message to the Coast Guard workforce about the holiday stating: "Juneteenth is not merely a footnote to African American history but represents a solidarity call for the country as a whole... recognizing and celebrating Juneteenth continues the Coast Guard's dedication to equity, diversity, inclusion, and belonging, which are integral tenets to the success of our mission and overall readiness."


"FAIR WINDS AND FOLLOWING SEAS" TO CDR CHAMBERS

CIVIL RIGHTS SERVICE PROVIDERS ANSWERED THE CALL FOR TRAINING

Over 400 U.S. Coast Guard supervisors logged into a virtual Reasonable Accommodation (RA) session on June 9th. The Civil Rights Regional Directors facilitated the training with participants. Directors defined RA and what is or isn't within its scope, advised on how to respond to RA requests and how to interact with requestors, and much more. Attendees now know that a reasonable accommodation is a change or adjustment to a work environment that permits a qualified applicant or employee with a disability to participate in the job application process, to perform the essential functions of a job, or to enjoy the benefits and privileges of employment equal to those enjoyed by employees without a disability. A reasonable accommodation may include acquiring or modifying equipment or devices, job restructuring, part-time or modified work schedules, reassignment to a vacant position, adjusting or modifying examinations, training materials, or policies, personal assistance, providing readers and interpretors, making the workplace readily accessible to and usable by persons with disabilities. SHOULD YOU PROVIDE A REASONABLE ACCOMMODATION FOR VALID RELIGIOUS BELIEFS?

In a recent case, the Equal Employment Opportunity Commission (EEOC) determined that an Agency discriminated against an employee on the basis of his religion when the Agency forced him to use Leave Without Pay (LWOP) to observe the Sabbath. The Complainant requested a religious accommodation to his work schedule that would allow him to observe the Sabbath from sunset Friday until sunset Saturday. Although the Agency concluded that the Complainants' religious beliefs were valid, the Agency determined that his requested time off was not reasonable due to his position requirements and for contractual reasons. He was denied the requested schedule, but advised to request LWOP instead. The Complainant alleged unequal treatment between his coworkers, and felt that using LWOP on a weekly basis to observe his religion was an adverse employment action. The Agency regarded this as a proper accommodation for his religious practices and believed it showed a legitimate, nondiscriminatory reason for its actions. The Complainant filed an appeal with the EEOC which found that the Agency failed to present evidence that it put forward a good faith effort to accommodate the Complainant's religious needs. No evidence was given to show that by doing so would have imposed an undue hardship to the Agency. It was ordered, among other things, to provide the Complainant the religious accommodations, restore or compensate Complainant for any LWOP he was forced to use, and investigate the Complainant's entitlement to compensatory damages.
