A. CONVENING THE STATE FACILITIES BOARD

In accordance with DOD Instruction 1225.08, Reserve Component (RC) Facilities Programs and Unit Stationing, the South Dakota State Facilities Boards held a meeting at 1402 MDT, on 8 April 2020 via teleconference from Joint Force Headquarters, Rapid City, South Dakota.

C. ACTION ON MINUTES OF PREVIOUS MEETINGS

Mr. Berendes moved to approve the minutes of the 17 April 2019 South Dakota State Facilities Board meeting as presented. The motion was seconded by 1LT Jake Erpenbach and the motion was approved unanimously.

D. LONG RANGE CONSTRUCTION PLAN PROJECT SUMMARIES:

1. Number of projects reviewed – 30.
2. Number of projects recommended for joint construction – 1;
3. Number of projects recommended for unilateral construction – 30.
4. Number not recommended for construction – 0.

Ms. Elkins reviewed the 26 projects on the Long Range Construction Plan (LRCP) as identified on Enclosure 3 including four additional projects for the SDANG.

LTC Yost asked for a motion to approve the LRCP as identified on Enclosure 3 as revised. Mr. Berendes moved to approve the 2020 Long Range Construction Plan as presented on Enclosure 3 as revised with one project recommended for possible joint construction and 30 projects recommended for unilateral construction. The motion was seconded by Mr. Vogel and the motion was approved unanimously.

LTC Yost then requested that Mr. Dolney review the Operations and Maintenance Project List.

E. REVIEW OF 2020 OPERATIONS AND MAINTENANCE PROJECTS.

Mr. Dolney reviewed the 2020 Operations and Maintenance Project List as outlined in Enclosure 4.

LTC Yost referenced the timeliness of the Aberdeen AFRC Boiler project, a joint facility noting that the boiler failed.

1Lt Erpenbach moved to approve the 2020 Operations and Maintenance Project List as identified in Enclosure 4 with 22 projects recommended for unilateral construction and none recommended for joint construction. The motion was seconded by Mr. Berendes and the motion was approved unanimously.

F. REVIEW OF THE 2020 SOUTH DAKOTA TRAINING AREAS

The Board reviewed the updates to the South Dakota Training Areas report as outlined on Enclosure 5 with Ms. Elkins noting that there had been no changes from the prior year.

A brief discussion followed regarding the proposal for a joint project including the the South Dakota Ellsworth Development Authority, Ellsworth Air Force Base, South Dakota Game Fish and Parks and the South Dakota Army National Guard to acquire 20,000 acres of land east of Ellsworth Air Force Base. Mr. Vogel indicated that he would check on the status of the project and provide LTC Yost with an update.

Mr. Vogel moved to approve the Training Areas report as presented on Enclosure 5. The motion was seconded by 1LT Erpenbach and approved unanimously.

H. NEXT MEETING DATE

LTC Yost indicated the next meeting would be held around the same time next year. He stated that the CFMO staff will send out a notice for the next meeting rather than establishing a meeting date at this time

G. OTHER BUSINESS

LTC Yost then asked if there were any other general comments or questions for the State Facilities Board.
