1. **Overall:**

a. Since the FY11 MILCON budget was still pending as of this meeting, all projects programmed for FY11 will remain in FY11 until the budget is passed. Updates will be addressed as needed and at the very latest at the next CA JSRCFB in 2012.

b. IAW DODD 1225.7, Para 4.19.6, USMCR briefed that joint use can also include "the use of only one base support office, security force, fire

department, fuel farm, facilities repair and maintenance activity, and, where practical, contracting, civilian personnel, transportation activity, and supply and maintenance warehousing activity for each joint Reserve base and/or installation and/or enclave, unless a better value is available".

2. U. S. Army Reserve:

a. Bakersfield, PN 71902. Possible joint project with USMCR project (planned for Bakersfield). No change.

b. Moreno Valley, PN 12101. Discussed possible joint project with USMCR, but determined not enough land to go joint with USMCR. Discussed possibility of sharing land with Navy. See comments under Navy Reserve.

c. San Diego, PN 12316 & Los Angeles, PN 12562. New projects added to the list both validated as unilateral. Not currently in the FYDP.

d. Los Alamitos, PN 69623 & Concord, PN 69563. Projects awarded in FY10 and currently under construction. To be removed from list.

e. Parks CSTC, PN79166, PN77639, & PN73740. These three new projects were added to the list and all validated as unilateral. All other projects on Parks CSTC remain unchanged and are all unilateral.

f. Fort Hunter Liggett, PN71702, PN72284, & 78468. These three new projects were added to the list and all validated as unilateral. All other projects for Fort Hunter Liggett remain unilateral. Program dates changed for five projects (refer to project listing). PN71460, PN71035, 71038, & PN72106 were deleted because the requirement was no longer needed.

3. U. S. Navy Reserve:

a. NAS North Island, P937. New project validated as unilateral. Currently in the FYDP for FY14.

b. Moreno Valley, P202. New project currently in the FYDP for FY14. Facility is co-located with the Army Reserve. Possibility of joint use depending on siting and land availability. May be eligible for joint use by the "enclave" definition discussed in paragraph 1.b above.

4. U. S. Marine Corps Reserve:

a. Overall Note: Recent Force Service Review group determined that the Marine Corps Reserve shall consolidate capacity in Southern California. Exploring the possibility of acquiring land in Pico Rivera/Los Alamitos with the Army National Guard.

b. San Jose/San Bruno, P-107. Possible joint project with USAR TBD. High need for relocation of project within a 50-100 mile radius of San Bruno. Siting issues will push the program year to at least 2018.

c. Bakersfield, P-220. Possible joint project with USAR. Acquisition of real property is also an issue in this area. Same note above regarding project P-107 status.

d. Camp Pendleton, P-230. New project validated as unilateral. Discussed the possibility of joint use with USAR Camp Pendleton project PN 69603 but due to the unique requirements of medical logistics storage along with the current program year of FY12, joint use is not an option. Currently in the FYDP for FY12.

e. Miramar, P-310. New project validated as unilateral. Currently in the FYDP for FY13. Final siting of USAR Miramar project PN 77238 affects the final siting for this project.

f. Twenty-Nine Palms (P-092), Miramar, Seal Beach, & Camp Pendleton. These last four projects on the USMCR list are either in design or under construction and will be removed from the list.

5. U. S. Air Force Reserve:

a. Beale AFB, BAEY104001A & BAEY104003. New projects added to the list both validated as unilateral. Not currently in the FYDP.

b. Beale AFB, BAEY104005. New project added that will be explored for possible joint use with 548 ISR Group (Air National Guard) at Beale. Not currently in the FYDP.

c. March ARB, PDPG080243, PDPG090564, PDPG090566, PDPG090565, PDPG090567, & PDPG070153. Six new projects added all validated as unilateral. None of these are currently in the FYDP.

d. March ARB, PDPG030120P1 & PDPG080244. Both projects were programmed for 2012 last year, but have since fallen off the FYDP.

e. March ARB, PDPG050237 & Travis, XDAT089021. Both projects were funded in FY10 and are currently under construction.

f. All other projects remain unchanged and are all unilateral.

6. Air National Guard:

a. Beale, BAEY029154 & Moffett, QMSN019029. Both projects received design funds and are programmed for FY12.

b. Fresno, HAYW000256, HAYW049096, HAYW049097, & HAYW969537. Removed from the list in 2010, but added again in 2011. Decision is pending to determine if Fresno still needs these requirements.

c. Fresno, HAYW109014. Design was funded in FY10 and construction funding was expected in FY11. The design was subsequently de-funded and the project re-programmed as an ECIP project with construction possible in FY12.

d. Moffett, QMSN099105 & QMSN099107. New projects both validated as unilateral. Currently in the FYDP for FY17 & FY 15 respectively.

e. Moffett, QMSN019030. Requirements for this project have been incorporated into QMSN092802 and project QMSN019030 has been removed from the installation master plan.

f. Six of the remaining Air National Guard (CAANG) projects changed program year (see project listing) and the rest remain unchanged. They are all recommended for unilateral construction. They support specific missions that are not viable candidates for joint construction.

7. Army National Guard:

a. Sacramento, #060001 and #060002. These are two phases of new Joint Forces Headquarters building and will be joint with the Air National Guard. No change in their current status.

b. Fort Irwin, #060413. Program year changed to 2013. Project is still unilateral.

c. Eight new projects added (see project listing). All eight projects were validated as unilateral. They are not currently in the FYDP.

c. All other projects remain unchanged and are all unilateral.

G. OTHER BUSINESS

1. Reviewed the OASD/RA website <http://ra.defense.dodlive.mil/> as the new "one-stop shop" for all matters related to the JSRCFB. Final minutes for the 2011 CA JSRCFB will be posted to this website for all to view.

2. CA Air National Guard reported that the Combat Communications Squadron in the San Fernando Valley is moving out of the equipment warfare center in 6-12 months. 10 acres will be available for training and the Supply Warehouse and AGE Facility will be under-utilized. If any Reserve Component is interested in using the location for training, contact the CA ANG.






