A. CONVENING THE BOARD

MAARNG: The Massachusetts Army National Guard presented a total of 15 projects consisting of 1 new project and 14 projects for unilateral recertification. The new project is alterations to an existing Readiness Center in Quincy MA. Though interest in participating in a joint project at the Quincy location was expressed by the Army Reserve, the site does not have adequate space or land to support additional stationing.

All training facilities and ranges at the MTA Camp Edwards are available for Joint use to support training requirements though construction is certified as unilateral.

USAR: The Army Reserve presented a total of 3 projects, two were recertified unilateral and one was recommended for unilateral construction due to geographic locations and specific mission requirements.

ANG: The Air National Guard presented a total of 15 projects, three were recertified unilateral and 12 projects were certified unilateral due to stationing, mission, and funding constraints. Interest was expressed by the Air National Guard to incorporate the MA ARNG into their Main Gate Project (AXQD122362) due to its proximity to the Army Aviation Facility. The MA ARNG will further evaluate the feasibility to proceed jointly with the Air National Guard on this project.

USAFR: The Air Force Reserve presented a total of 3 projects all were recommended for recertification of unilateral construction due to their geographic locations and specific mission requirements. The Air Force Reserve expressed interest in other services that use and benefit from their physical fitness facilities to contribute to the construction of their planned addition. Both the ANG and MA ARNG agreed to evaluate and discuss with leadership for possible future involvement with the USAFR on this project.

USMCR: The USMCR presented 0 projects.

USNR: The USNR presented 0 projects.




