- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area entails an 80-100-foot-wide linear area approximately 0.6 miles along Mission street and Dienhard Lane in McCall, Idaho. The review area is generally located along the upper terrace approximately 60 vertical feet and 600 linear feet from the North Fork (NF) Payette River and it's adjacent wetlands. A wetland delineation was performed and identified three separate palustrine emergent (PEM) wetland cells along the western boundary of the review area (W-1, 0.03 acres; W-2, 0.01 acres; and W-3, 0.04 acres). Identified wetlands are located along the western side of the review area between the roadway and the NF Payette River. Generally, the wetlands exhibit historical disturbances from road crossings, old fills, and incidental impacts from adjacent uses such as gravel pits and development. The potential for these resources to continue beyond the review area to other waters was considered, evaluated, and determined that no downstream connection exists.

Wetlands 1 and 2 drain to an upland swale heading to the southwest. No ordinary high-water mark (OHWM) was identified within the swale. The swale terminates into an historically excavated aggregate pit that still maintains minor activities. The terminus is located at latitude 44.891153, longitude -116.106421. The excavated area is a closed basin upland area which has no outlet or other aquatic resources. Wetlands 1 and 2 are separated from the NF Payette River (closest RPW) by approximately 600 linear feet, and 60 vertical feet.

Wetland 3 has a gradual slope (1-4%) to the west and drains to a small swale or ditch feature with no apparent OHWM. The swale terminates near latitude 44.894138°, longitude -116.106318° where the ground elevation rises approximately 5 feet from the wetland elevation to enclose Wetland 3 in a confined basin. This feature in its totality is separated from the North Fork Payette River by uplands, roadway fills and an RV Park, and is located approximately 500 linear feet, and 40 vertical feet from the NF Payette River.

Wetlands 1,2 and 3 are small emergent wetlands that are not adjacent to any RPW or non-RPW and are isolated features.

The current use, past use, or susceptible use in interstate or foreign commerce has been considered, evaluated, and determined that no reasonable contribution to current, past or future interstate or foreign commerce occurs within the non-navigable, intra-state wetlands 1-3. Per 33 CFR 328.3(a)(3)(i-iii), the evaluation included recreational activities, fish and shellfish production, industrial uses, and other uses. The three seasonal PEM wetland cells within the review area total 0.08 acres and contain fragmented habitat near the toe slope of historic roadway fills (e.g. Mission St. and Unnamed gravel roadways). Due to the roadway activity on both sides of the wetlands and nearby airport activities the degraded wetland habitat would not provide reasonable migratory bird habitat nor furbearer habitat. There is no documented recreation including bird watching, hunting, or trapping within the fragmented and degraded seasonal wetlands. Also, no fish production, shellfish production or industrial uses are documented with the three wetlands located in the review area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
