(U) Evaluation of the Defense Cover Program's Oversight Process

January 30, 2017

(U) Objective

(U/FOUO) Our objective was to determine whether the Human Intelligence and Sensitive Activities (H&SA) Directorate's oversight review process fully addressed the five oversight steps required by Department of Defense (DoD) Instruction S-5105.63, "Implementation of DoD Cover and Cover Support Activities," June 20, 2013:

- (U) publication of pre-visit checklists and special interest items;
- (U) pre-visit audit of cover plans, cover mechanisms, and review of organizational cover program guidance;
- (U) site visits led by the Office of the Under Secretary of Defense for Intelligence (OUSD[I]) to assess the effectiveness of Componentlevel programs;
- (U) a post-visit report identifying findings and recommendations, as well as best practices; and

(U) Objective (cont'd)

 (U) continuous follow-up to assist with the remediation of findings and to monitor the implementation of recommendations.

(U) Background

- (U) Cover is the concealment of true identity or organizational affiliation with assertions of false information as part of, or in support of, official duties to carry out authorized activities and lawful operations.
- (U) The Defense Cover Program (DCP) is a DoD program designed to protect missions, operations, organizations, personnel, facilities, equipment, capabilities, administrative or management systems, financial activities, and programs that cannot otherwise be successfully accomplished through the application of other types of security measures.
- (U) Oversight reviews of the DCP are led by the OUSD(I), H&SA Directorate staff and supported by subject-matter experts from the Defense Cover Office, Defense Intelligence Agency, and other DoD Components.

(U) Finding

(U//Touc) The H&SA Directorate conducted DCP oversight reviews to verify compliance with applicable laws, regulations, directives, and policies. We identified through data collection, interviews, and physical observations that the H&SA Directorate's oversight review process included the five oversight steps required by DoD Instruction S-5105.63. However, the oversight review process is not documented in H&SA Directorate policy or procedures.

(U//FOUO) As a result, the DCP oversight review process does not have assurance that the H&SA Directorate will properly and consistently carry out its recurring DCP oversight review responsibilities. Formal H&SA Directorate guidance, such as a Standard Operating Procedure, will ensure that roles and responsibilities for the H&SA staff and support personnel are established to more effectively plan, execute, and maintain continuity of the DCP oversight review process.

(U) Evaluation of the Defense Cover Program's Oversight Process

(U) Recommendation

(U) We recommend that the Office of the Under Secretary of Defense for Intelligence's Human Intelligence and Sensitive Activities Directorate:

- (U) create written instructions in the form of a Standard Operating Procedure, or similar type guidance, to standardize the Defense Cover Program oversight review process; and
- (U) provide us the timeline and milestones for the development of the Standard Operating Procedure.

(U) Management Comments and Our Response

(U//F8U0) The H&SA Director agreed with the recommendation to create a Standard Operating Procedure to standardize the DCP Oversight Review process and provided a projected completion date of May 1, 2017. The H&SA Director added that, upon completion, a copy will be provided to our office. The comments and planned corrective action are responsive and no additional comments are required.

SUBJECT: (U) Final Report--Evaluation of the Defense Cover Program's Oversight Process (Project No. D2015-DISPA2-0044.000)

(S//NF) We are providing this final report for your information and use. The objective of this report was to determine whether the Office of the Under Secretary of Defense for Intelligence, Human Intelligence and Sensitive Activities Directorate's (H&SA) oversight review process used for the Defense Cover Program (DCP) fully addressed the five oversight steps required by DoD Instruction S-5105.63, "Implementation of DoD Cover and Cover Support Activities," June 20, 2013. We conducted this evaluation OSD/JS (b)(1) 1.4(c) in accordance with the "Quality Standards for Inspection and Evaluation," published in January 2012, by the Council of the Inspectors General on Integrity and Efficiency.

(U//FOUO) We determined that the DCP oversight review process does not have assurance that the H&SA Directorate will properly and consistently carry out its recurring DCP oversight responsibilities because it does not have internal guidance standardizing the DCP oversight review process. We recommended the H&SA Directorate create a Standard Operating Procedure (SOP) to ensure that roles and responsibilities for the H&SA staff and support personnel are established to more effectively plan, execute, and maintain continuity of the DCP oversight review process. The H&SA Director agreed with the recommendation to create an SOP to standardize the DCP oversight review process.

(U//FOUO) We considered management comments on a draft of this report when preparing this final report. Comments from the Director, H&SA, conformed to the requirements of DoD Instruction 7650.03, "Follow-up on Government Accountability Office (GAO), Inspector General of the Department of Defense (DoD), and Internal Audit Reports," December 18, 2014; therefore, we do not require additional comments.

(U) Introduction

(U) Objective

(U//FOUO) Our objective was to determine whether the Human Intelligence and Sensitive Activities (H&SA) Directorate's oversight review process fully addressed the five oversight steps required by Department of Defense (DoD) Instruction S-5105.63, "Implementation of DoD Cover and Cover Support Activities," June 20, 2013.

(U) Background

(U) DoD Instruction S-5105.63 states that cover² is a mission enabler, not a type of operation. DoD develops, employs, and manages cover and cover support activities³ that are realistic, credible, supportable, verifiable, and compliant with U.S. laws, policies, procedures, and standards.

(U) The DCP was developed to protect missions, operations, organizations, personnel, facilities, equipment, capabilities, administrative or management systems, financial activities, and programs that cannot otherwise be successfully accomplished through the application of other types of security measures. The DCP is a DoD-wide program to facilitate the consistent and secure implementation of policies and procedures in the cover plan review, coordination, approval, deconfliction, registration, establishment, use, accountability, maintenance, termination, and oversight of cover and cover mechanisms used by or in support of the DoD Components. OSD/JS (b)(1) 1.7(e)

(U) The three Department of Defense issuances for cover are:

 (U) DoD Directive S-5205.61, "Defense Cover and Cover Support Activities," July 15, 2014, establishes policy and assigns responsibilities for all DoD cover and cover support activities that comprise the DCP.

² (U) Cover. The concealment of true identity or organizational affiliation with assertions of false information as part of, or in support of, official duties to carry out authorized activities and lawful operations.

- (U) DoD Instruction S-5105.63, "Implementation of DoD Cover and Cover Support Activities," June 20, 2013, establishes policy and procedures and assigns responsibilities for the conduct of DoD cover and cover support activities as part of the DCP. This instruction also includes the guidance for USD(I)'s oversight of the DCP.
- (U) DoD Manual S-5105.63-M, "DoD Cover and Cover Support Security Classification Guide (SCG)," Incorporating Change 1, Effective October 16, 2013, implements policy, assigns responsibilities, and prescribes procedures for the classification of information concerning DoD cover and cover support activities, and the DCP.

(U) Cover Oversight Role and Responsibilities

(S//NF) In accordance with DoD Instruction S-5105.63, DCP oversight reviews are led by the OUSD(I)'s H&SA Directorate. In accordance with DoD Directive S-5205.61 and DoD Instruction S-5105.63, the H&SA Directorate is supported OSD/JS (b)(1) 1.4(c)

- (U) DoD Instruction S-5105.63 requires the DCP oversight reviews to include five controls:
 - (U) publication of pre-visit checklists and special interest items;
 - (U) pre-visit audit of cover plans, cover mechanisms, and a review of organizational cover program guidance;
 - (U) site visits led by OUSD(I) to assess the effectiveness of Component-level programs;
 - (U) a post-visit report identifying findings and recommendations, as well as best practices; and
 - (U) continuous follow-up to assist with the remediation of findings and to monitor the implementation of recommendations.

(U) Review of Internal Controls

(U) DoD Instruction S-5105.63 states that oversight reviews are led by H&SA

Directorate staff and supported by subject-matter experts from OSD/JS (b)(1) 1.7(e)

to include the five oversight steps required by DoD Instruction S-5105.63. However, some processes and procedures were not formalized or documented. We identified an internal weakness with the H&SA Directorate's oversight review process. Specifically, the H&SA Directorate does not have a formalized DCP oversight review process documented in a Standard Operating Procedure or similar type policy guidance.

(U) Finding

(U//FOUO) The H&SA Directorate Needs to Create a Formalized Procedure That Identifies How to Conduct the DCP Oversight Review Process

(U//FOUO) The H&SA Directorate conducted DCP oversight reviews to verify compliance with applicable laws, regulations, directives, and policies. We identified through data collection, interviews, and physical observations that the H&SA Directorate's oversight review process included the five oversight steps required by DoD Instruction S-5105.63. However, the oversight review process is not documented in H&SA Directorate policy or procedures.

(U//FOUO) As a result, the DCP oversight review process does not have assurance that the H&SA Directorate will properly and consistently carry out its recurring DCP oversight review responsibilities. Formal H&SA Directorate guidance, such as a Standard Operating Procedure, will ensure that roles and responsibilities for H&SA staff and support personnel are established to more effectively plan, execute, and maintain continuity of the DCP oversight review process.

(U) Human Intelligence and Sensitive Activities Directorate's Oversight Procedures

(U) We evaluated whether the oversight reviews conducted by the H&SA Directorate fully addressed the five oversight steps required by DoD Instruction S-5105.63.

(U) Pre-Visit Checklists and Special Interest Items

(U//FOUO) DoD Instruction S-5105.63, Enclosure 3, requires that oversight reviews include a pre-visit checklist and special interest items. The H&SA Directorate has a pre-visit checklist and special interest items document that is sent to the DoD Components 30 days prior to an oversight review. The pre-visit checklist and special interest items

are completed and returned to the H&SA Directorate prior to the oversight review as a read ahead. The pre-visit checklist and special interest items are reviewed during the oversight review.

(S//NF) We confirmed the existence of the pre-visit checklist and special interest items document through our data collection request to the H&SA Directorate. The pre-visit checklist and special interest items are combined into one document that is commonly referred to as the checklist by the defense cover community. We corroborated the use of the checklist during our interviews with the 11 DoD Components' cover support personnel. We asked each of the 11 DoD Components' cover support personnel what the H&SA Directorate provided in advance of the oversight review. All of the Components' cover support personnel responded that they received the checklist.

(U//FOUO) Additionally, the H&SA Directorate staff included us on all correspondence to OSD/JS (b)(1) 1.7(e) in preparation for OSD/JS (b)(1) 1.7(e) in preparation for OSD/JS (b)(1) 1.7(e) oversight review scheduled for OSD/JS (b)(1) 1.7(e). That correspondence included the checklist. Then, on OSD/JS (b)(1) 1.7(e), we witnessed the H&SA Directorate's use of the checklist during OSD/JS (b) oversight review. While we were able to confirm the pre-visit checklist and special interest item document existed and were used, we noted that the H&SA Directorate does not have the process on how to implement the use of the pre-visit checklist and special interest item document codified in an internal policy or procedure.

(U) Pre-Visit Audit of Cover Plans, Cover Mechanisms, and a Review of Organizational Cover Program Guidance

(U//FOUO) DoD Instruction S-5105.63, Enclosure 3, states that oversight reviews include pre-visit audits of cover plans, cover mechanisms, and a review of organizational cover program guidance. The H&SA Directorate staff informed us that a data collection request is distributed to the DoD Components 30 days prior to the oversight review to allow the oversight body time to review the information prior to the actual oversight review. Anomalies are exploited during the oversight review.

(U//FOUO) We confirmed that the H&SA Directorate conducted the pre-visit audits of cover plans, cover mechanisms, and reviewed organization cover program guidance through interviews with the 11 DoD Components' cover support personnel. For example:

- (U//POUO) OSD/JS (b)(1) 1.7(e) informed us that the H&SA Directorate follows up with several phone calls weekly to sync up data call and documents prior to the oversight review.
- (S//NF) OSD/JS (b)(1) 1.4(c) said that he believed the H&SA staff probably knew the potential findings before their arrival due to the review of the data call and the focus area of the oversight review.
- (S//NF) OSD/JS (b)(1) 1.4(c) stated that the H&SA oversight body conducted a comparison of over plans and other documents in the read-ahead.

(U//FOUO) We were also able to corroborate H&SA's pre-visit audit of the cover plans, cover mechanisms, and review of organizational cover program guidance at oscillation pre-oversight meetings when the H&SA Directorate would meet with the oversight body to discuss the data call information. Furthermore, we witnessed the H&SA's oversight body's level of knowledge of OSD/JS (b)(1) 1.7(e) during our physical observation of oversight review OSD/JS (b)(1) 1.7(e). Although the H&SA Directorate's staff conducts a pre-visit audit of cover plans, cover mechanisms, and a review of organizational cover program guidance, we identified that the H&SA Directorate does not have the process of the pre-visit audit documented in an internal policy or procedure.

(S//NF) We corroborated the H&SA Directorate's oversight process through multiple methods: interviews of 11 DoD Components' cover support personnel, review of 12 findings and recommendations reports generated by the H&SA Directorate to the DoD Components from oversight reviews, and through observing the oversight review of the OSD/JS (b)(1) 1.4(c)

- (S//NF) Through our interview process, the 11 DoD Components identified that they had received at least one oversight review. OSD/JS (b)(1) 1.4(c)
- (U//FOUO) We received a total of 12 findings and recommendations reports from the H&SA Directorate staff or the DoD Components' cover support personnel which confirmed the H&SA Directorate staff's testimonial evidence pertaining to the oversight reviews. The 12 findings and recommendations reports span from 2011 to 2016.
- (U//FOUO) We were included in the planning and execution of OSD/JS (b)(1) 1.7(e) oversight review. The findings and recommendations report for oversight review is still ongoing. We received all electronic correspondence between the H&SA Directorate staff and OSD/JS (b)(1) 1.7(e) throughout the duration of the oversight review. OSD/JS (b)(1) 1.7(e)

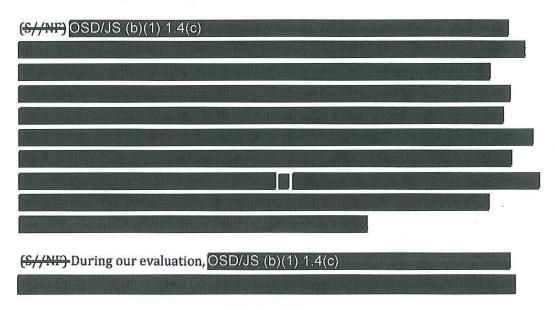
The H&SA Directorate's staff

visited the Components to conduct an in-call with the commanders, reviewed the checklists, and answered questions.

(S//NF) Based on our analysis derived from the interviews with the H&SA Directorate staff, interviews with the 11 DoD Components' cover support personnel pertaining to previous oversight reviews, our reviews of the 12 findings and recommendations reports, and through the physical observations, we concluded that the H&SA Directorate performed oversight reviews and staff assistance visits in accordance with DoD Instruction S-5105.63. However, we noted that the H&SA Directorate's oversight review and staff assistance visit processes are not formally documented in internal policy or procedures.

(U) Post-Visit Report Identifying Findings and Recommendations, as Well as Best Practices

(U//FOUO) DoD Instruction S-5105.63, Enclosure 3, states that oversight reviews include a post-visit report identifying findings and recommendations as well as best practices. The H&SA Directorate staff generates a findings and recommendations report approximately 60 to 90 days after the oversight review. The post-visit report identifies issues discovered during the review and provides recommendations along with a timeframe to fix the noted issue(s). The report also identifies any best practices discovered during the oversight review.

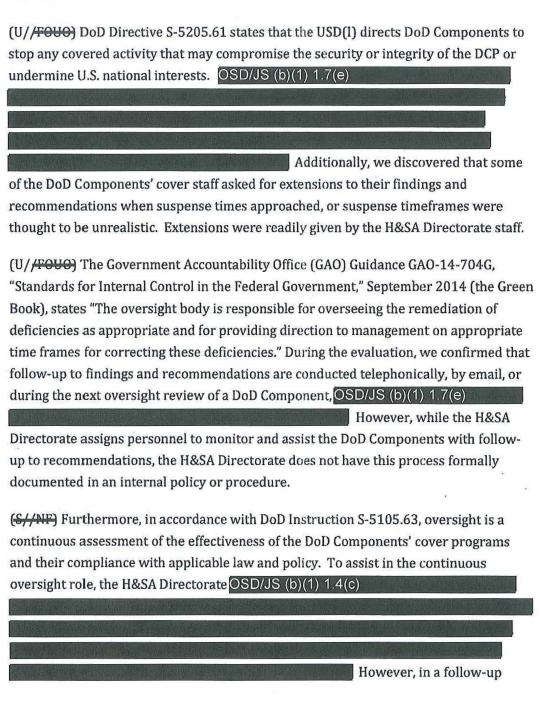

(S//NF) Based on our reviews of 12 findings and recommendations reports spanning
from 2011 to 2016, generated by the H&SA Directorate staff to the DoD Components'
cover support staff from oversight reviews and our interviews with the H&SA
Directorate staff and DoD Components' cover support staff, we confirmed that post-visit
reports are generated and distributed after an oversight review is conducted. While
most of the post-visit reports were distributed within 90 days of the oversight review,
we identified four DoD Components that received post-visit reporting 120 days after the oversight review. OSD/JS (b)(1) 1.4(c)
We also noted that while the H&SA Directorate has a post-visit
report process, it is not formally documented within an internal policy or procedure.
(U) Continuous Follow-Up to Assist With Remediation of
Findings and to Monitor the Implementation of
Recommendations
(U// POUO) DoD Instruction S-5105.63, Enclosure 3, states that oversight reviews
include continuous follow-up to assist with remediation of findings and to monitor the
implementation of recommendations. The H&SA Directorate staff reported that follow-
up is conducted by assigning an H&SA Directorate cover staff representative to the

its staff was assigned to which of the DoD Components and that the H&SA Directorate cover staff were responsible for maintaining communication with their assigned DoD Components. The H&SA Directorate cover staff's assistance is conducted via telephone and email.



discussion with the H&SA Directorate cover staff, we verified that neither is formally documented in an internal policy or procedure.

(U) Conclusion

(S//NP) Based on our review of DoD Directive S-5205-61 and DoD Instruction S-5105.63, the 12 findings and recommendations reports generated by H&SA Directorate staff substantiating the oversight review process, interviews with the H&SA Directorate staff regarding the DCP oversight review process, and interviews with the 11 DoD Components' cover support staffs to corroborate the H&SA Directorate's oversight review process, we concluded that H&SA Directorate adequately performed DCP oversight reviews implementing the five oversight steps required by DoD Instruction S-5105.63. However, we also concluded that the H&SA Directorate lacks an internal policy or procedures standardizing the Directorate's DCP oversight process. An H&SA Directorate policy or procedures would serve as a permanent record of reference for quality control providing reasonable assurance that the Directorate and its personnel comply with professional standards, applicable legal and regulatory requirements, and consistently carry out its cover oversight responsibilities.

(U) Recommendations, Management Comments, and Our Response

(U) We recommend that the Office of the Under Secretary of Defense for Intelligence's Human Intelligence and Sensitive Activities Directorate:

- (U) create written instructions in the form of a Standard Operating Procedure, or similar type guidance, to standardize the Defense Cover Program oversight process; and
- (U) provide us the timeline and milestones for the development of the Standard Operating Procedure.

(U) Office of the Under Secretary of Defense for Intelligence, Human Intelligence and Sensitive Activities Comments

(U) The Director, Human Intelligence and Sensitive Activities agreed with the recommendation, providing the following comments:

- (U//FOUO) I agree with your recommendation for development of written instructions in the form of a Standard Operating Procedure (SOP) to standardize the DCP oversight process.
- (U//FOUC) My office is currently drafting formal internal procedures addressing conduct of DCP Oversight Reviews based upon your report's recommendations. These procedures will be captured in the form of a SOP with a projected completion date of May 1, 2017. Upon completion, we will provide your office a copy of the SOP.

(U) Our Response

(U) Comments from the Director, Human Intelligence and Sensitive Activities, addressed all specifics of the recommendation and no further comments are required.

(U) Observation 1

(S//NF) Throughout this evaluation, OSD/JS (b)(1) 1.4(c)

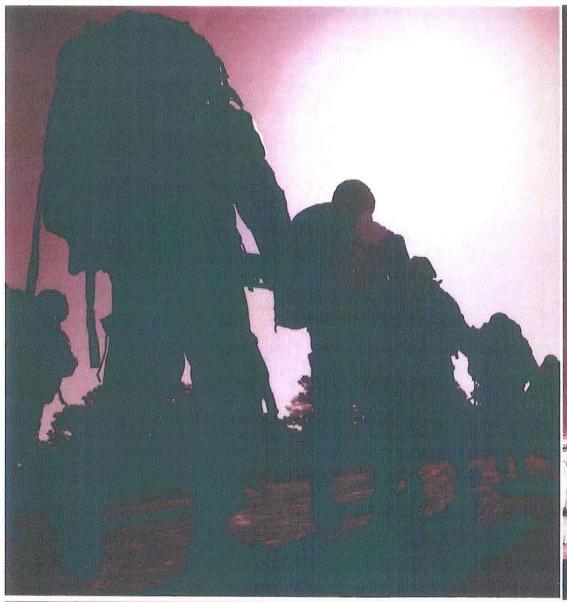

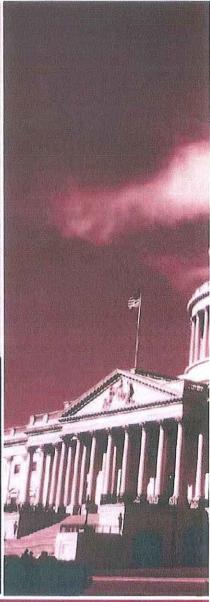
