U. S. COAST GUARD AMENDMENT NO. 3

1. Purpose. This Amendment provides Navy and Coast Guard changes to the U. S. Navy Uniform Regulations, 1969, as amended for Coast Guard use.

3. Summary. Articles or paragraphs which have been modified or added by this Amendment are indicated by a star. However, purely editorial changes which do not change the meaning are not marked. The major changes made by this Amendment are summarized as follows:

- d. Article 0236.1.b. Prescribes manner of wearing the Coxswain Insignia by commissioned and warrant officers.
- e. Article 0236.1.b.(9). Authority for personnel advanced to officer status to wear Officer in Charge and/or Coxswain Insignia.
- f. Article 0236.2.w. Gives description of Officer in Charge Insignia.
- g. Article 0236.2.x. Gives description of Coxswain Insignia.
- h. Article 0351.3.a. Prescribes Coast Guard shield to be worn on Service Dress Light Blue Uniform by women officers in the Coast Guard Reserve.
- i. Article 0640.3. Items added to list of organizational clothing for officer candidates.
- j. Article 1012.1. Working uniforms are not authorized for wear while traveling between work and local residence.
- k. Article 1021.5. A Coast Guard shield will not be worn on the Navy enlisted work blue jumper by personnel E-6 and below.
- l. Article 1117.1.f. (1), (2) and (3). Prescribes manner of wearing new Coxswain Insignia.
- m. Article 1117.2.o. Gives description of new Officer in Charge Insignia.
- n. Article 1117.2.p. Gives description of new Coxswain Insignia.
- o. Article 1441.2. Prescribes manner of wearing the Operational Distinguishing Device "O".
- p. Article 1441.7. Operational Distinguishing Device "O" is authorized for wear on Coast Guard Commendation Medal, Coast Guard Achievement Medal and Coast Guard Unit Commendation Ribbon awarded for operational performance.

- ★ 0111.1.d. However, notwithstanding paragraphs (a), (b) and (c) above, in certain circumstances it will be necessary to restrict the wearing of beards and moustaches. For example, beards and moustaches cannot be permitted to interfere with the mask-to-skin seal required for the proper wearing of oxygen masks, gas masks, or OBA equipment. Similarly, for sanitary reasons, personnel engaged in food preparation and medical personnel who may be engaged in the surgical care of patients (emergency or otherwise) will remain clean-shaven, except that they may wear a neatly trimmed moustache. Also for uniformity during public appearances as a distinctive element of the Coast Guard, personnel who are assigned to Ceremonial Honor Guard will be clean-shaven.

- ★ 0111.1.f. The Superintendent of the Coast Guard Academy and the Commanding Officers of the Training Centers at Cape May and Alameda are authorized to establish more restrictive grooming standards for cadets, recruits, and members of the permanent party.

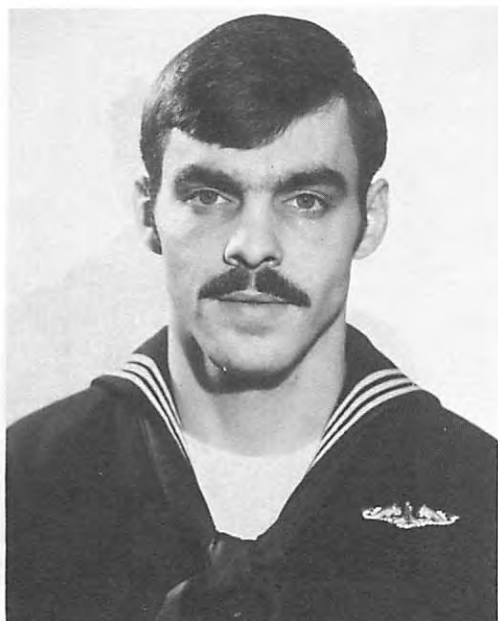
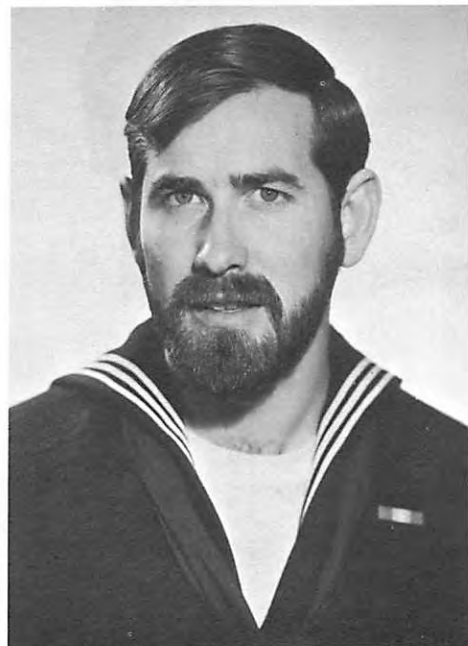
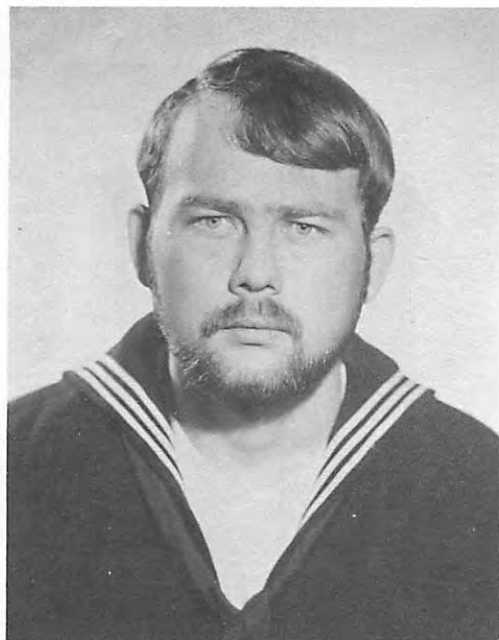
- ★ 0128.5. Name tags when prescribed shall be paid for through appropriated funds.

0129.2.e. Coveralls. Allowances of coveralls are authorized to be established by district commanders for necessary use by Marine Inspection, COTP, and other personnel in the performance of their duties. Such coveralls will be similar in style to those described in MIL-C-2202, except that they will be made of white cotton drill. Coast Guard identification will consist of the initials "USCG" placed in a straight line across the left breast and back of the coveralls. All lettering will be dark blue, cable #70077, one-inch block type for the front and three-inch block type for the back.

0129.2.f. Judicial Robes. An allowance of judicial robes is authorized to be established by Commandant (L) and all district commanders and other units with Military Judges attached for necessary use by the Military Judges in conjunction with their court-martial duties, Court of Military Review duties, and on appropriate ceremonial occasions. The robes shall be of commercially available design and shall be individually fitted to the Military Judge. Identification shall consist of the name and rank of the judge to whom issued and "MILITARY JUDGE, USCG" placed on the provided identification tag within the robe.

01212.2. Protective Head Gear. Allowances for hardhats are authorized to be established by district commanders for use of COTP Pier and Dangerous Cargo Patrolmen, Marine Inspectors, and other personnel as necessary. The hardhats shall be visor type, similar to that described under FS#8415-836-8618, white in color with white chin strap, the underside of the visor to be green. Each hardhat shall have a two-inch full colored Coast Guard Emblem (decal) centered and affixed on the front as insignia with the bottom 1-1/4" above visor.

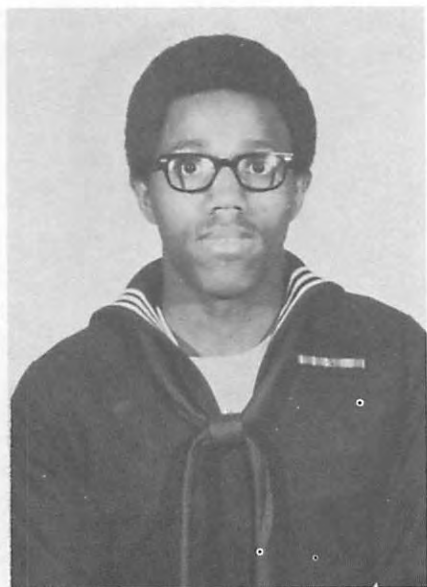
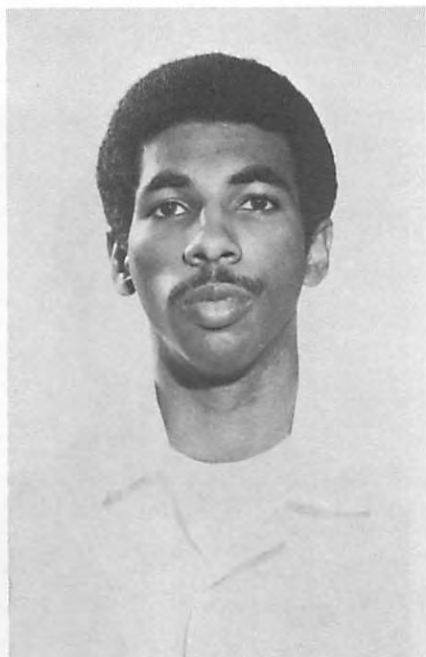


FRONT VIEW

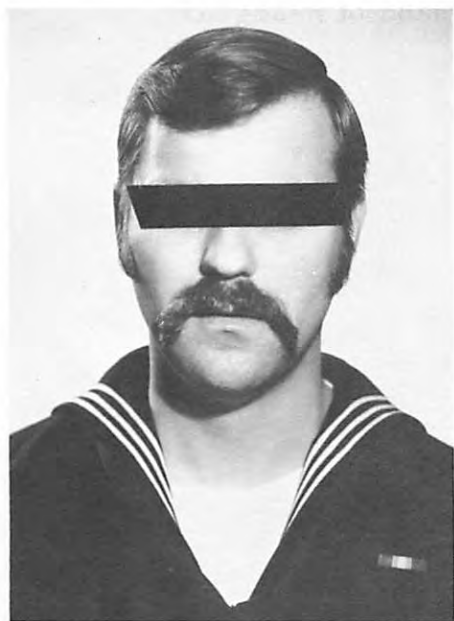

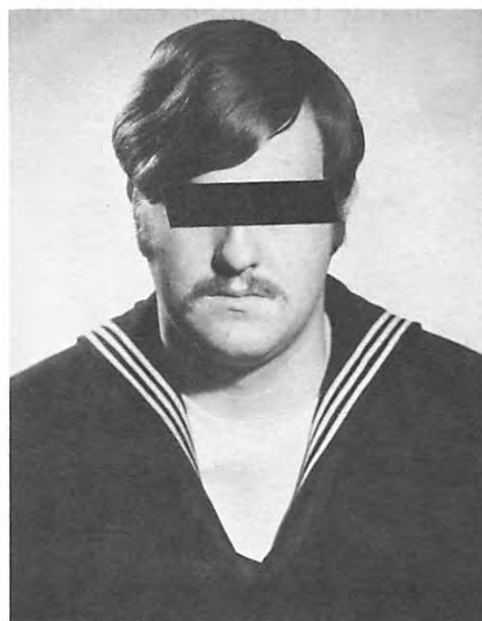

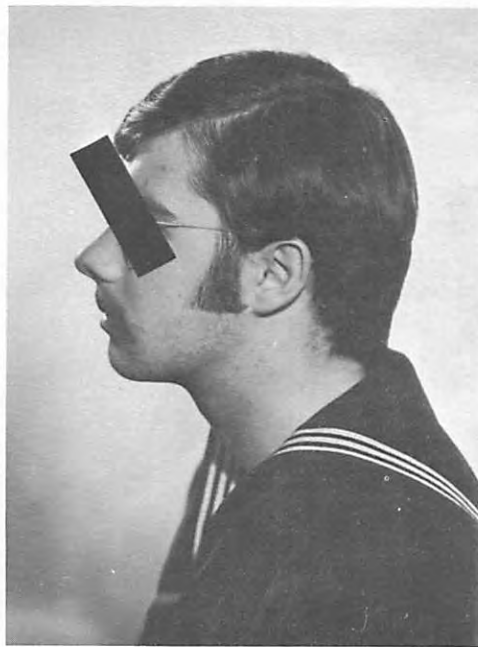

0232. 1. c. (4) Specialty title changed from Ship's Clerk to Personnel Administration in the Coast Guard.

★ 0232. 1. c. (5) Specialty title changed from Radio Electrician (Operations) to Communications in the Coast Guard.

0232. 1. c. (6) Specialty title changed from Machinist (General) to Naval Engineering in the Coast Guard.

0232. 1. c. (7) Specialty title changed from Carpenter to Material Maintenance in the Coast Guard.

★ 0232. 1. c. (10) Specialty title changed from Electronics Technician to Electronics in the Coast Guard.

0232.1.c.(12) Specialty title changed from Machinist (Aviation) to Aviation Engineering in the Coast Guard.

0232.1.c.(15) Specialty title changed from Photographer to Public Information in the Coast Guard.

- ★ 0236. 1. b. The wearing of the Coxswain Insignia by commissioned and warrant officers will be as prescribed by the Navy for breast insignia in this Article.

- ★ 0236.1.b.(9). Enlisted personnel who have been awarded the Coxswain Insignia and/or Officer in Charge Insignia who are subsequently advanced to officer status may continue to wear the enlisted insignia until they qualify for the Command at Sea Insignia at which time the Officer in Charge Insignia shall be replaced by the Command at Sea Insignia.

0236.1 BREAST INSIGNIA

c. Command at Sea Insignia

(1) Personnel authorized to wear the Command at Sea insignia shall wear this insignia in addition to any other breast insignia authorized.

(2) The large size Command at Sea insignia, as described in subparagraph 2. a. below, shall be worn on Full Dress uniforms. The miniature insignia, one-half size in dimension of the large Command at Sea insignia, shall be worn on all other uniforms.

(3) The Command at Sea insignia shall be worn as follows:

(a) Officers currently in command at sea shall wear the insignia on the right breast centered immediately above the pocket (or in the same relative position on uniforms which do not have a pocket in this position) except that on mess jackets it shall be centered on the lapel approximately 3-1/2" below the notch. When a unit commendation ribbon is worn on the right breast the insignia shall be centered immediately below the ribbon.

(b) Officers having previously held command at sea (but not currently in command) and who have been authorized to wear the insignia shall wear it on the left breast centered immediately below any ribbons, medals, or other breast insignia. When worn alone the insignia shall be centered immediately above the pocket except that on mess jackets it shall be centered on the lapel approximately 3-1/2" below the notch. (See Section 9-G, Personnel Manual (CG 207) for authority to wear Command at Sea insignia.)

0236.2. Description

a. Command at Sea Insignia. A gold color metal pin consisting of furled Commissioned Officer Cap device superimposed on a partially unfurled commissioned pennant showing thirteen stars. The shield shall be silver. One ray of all stars shall point up. The large device is 1-19/32" in width and 1-3/4" in height. The miniature device is 23/32" in width and 25/32" in height.

★ 0236.2.w. Officer in Charge Insignia. A sterling silver metal pin consisting of a rope grommet with fouled anchor with a Coast Guard shield superimposed on anchor which is $13/16$ " in height and $23/32$ " in width.

★ 0236.2.x. Coxswain Insignia. A silver plated, oxidized relieved satin finish consisting of curled waves and crossed oars with a superimposed compass rose which is $3/4$ " in height and 2" in width.

- ★ 0351. 3. a. A dark blue Coast Guard shield shall be worn on the Service Dress Light Blue Uniform. The shield shall be worn on a center line of the right sleeve, the lower point of the shield to be 1" above top corded edge of the cuff.

0640. MINIMUM OUTFIT FOR COAST GUARD OFFICER CANDIDATES.

1. In addition to those items listed in Article 0640.1. a. and 0640.1. b., of the basic regulations, the following items will be issued.

a. <u>Article</u>	<u>Quantity</u>
Cap, khaki, garrison	2
Shirt, blue chambray	2
Shoes, black general purpose	1 pr.
Towel, Bath, Large	4
Trousers, dungaree	2 pr.

Note: Navy new enlisted blue work uniform may be substituted for chambray shirt and dungaree trousers, however, items of one uniform may not be worn with the other.

- ★ 0640.3. In addition to their minimum outfit, male officer candidates shall have the following articles issued to them organizationally for use during the entire period of their training:

0640.4. Government owned clothing issued organizationally for use by officer candidates and intended for return upon completion of the training will be stencilled with the letters "USCG". In addition, to facilitate identification, a brief stencilled marking (letter, numeral, or both) may be appended to the basic marking. Either name tape, stencil or stamp markings may be used by officer candidates to mark all other clothing.

0641.1. Enlisted personnel of the regular Coast Guard or enlisted personnel of the Coast Guard Reserve selected while on active duty, who have previously received a clothing allowance, shall continue to maintain the minimum outfit prescribed in Article 1040 while undergoing training in the Officer Candidate Program in the rating of officer candidate.

0641.2. In addition, each candidate should report for training duty possessing the following items:

Handkerchiefs	as necessary
Padlock and key	1
Shoes, gymnasium or tennis	1 pr.
Shorts, gymnasium, khaki	1 pr.
Tapes, name	50
Toilet articles	as necessary

- ★ 1012.1. Working uniforms are not authorized for wear while traveling between work and the local residence. The working uniform may be worn to Service type facilities on base such as commissaries, exchanges, snack bars, dispensaries or disbursing office during working hours. The working uniform is not authorized for off-base wear in a liberty status.

- ★ 1021.5. New Navy Enlisted Working Uniform. Pending possible development of a new Coast Guard working uniform, a Coast Guard shield will not be prescribed for wear on the New Navy Enlisted Working Uniform. However, the rating badge prescribed by the Navy for that particular uniform will be worn by all petty officers E-4 through E-6.

1115.1.d. Gold Lace Service Stripes. - Chief petty officers and petty officers who have not less than 12 years' continuous active duty (full time duty) in the Coast Guard and/or Coast Guard Reserve, during which time they have fulfilled the requirements necessary for the award of the Coast Guard Good Conduct Medal, shall wear the gold lace service stripes on blue uniforms in lieu of scarlet stripes. Having once acquired the right to wear gold lace service stripes, that right continues throughout the duration of an enlisted man's service unless in an enlistment subsequent to the one in which the right is established he fails to qualify for a Coast Guard Good Conduct Medal, in which case the right to wear gold stripes shall at that time be terminated; and in addition, if the enlisted person is convicted by court-martial and the conviction has become final within the meaning of Article 76, Uniform Code of Military Justice, the right to wear gold stripes shall be terminated. When gold lace service stripes are worn a gold rating badge and Coast Guard shield shall be worn.

1115.2. Eligibility. - Enlisted personnel shall wear one service stripe for each full four years of service (other than on the retired list) in the Coast Guard, Navy, Marine Corps, Army, Air Force, Coast Guard Reserve, or any combination thereof.

1116. SHIRT COLLAR INSIGNIA

1. General Description. - Shirt collar insignia shall consist of a gold color metal foul anchor with a silver shield superimposed vertically on the shank of the anchor similar in design to the chief petty officer's cap device and of a size to be inscribed in a circle 15/16" in diameter. One, two or three silver stars shall be attached above the anchor stock to designate senior and master chief petty officers and the Master Chief Petty Officer of the Coast Guard, respectively. To be worn on both collar tips of the khaki shirt, blue flannel shirt, khaki tropical shirt and white tropical shirt in the same manner as prescribed in Article 0234 for officers' collar insignia.

- ★ 1117. 1. f. (1), (2) and (3). Enlisted members of the Coast Guard who are entitled to wear the Coxswain Insignia will wear it as prescribed by the Navy for breast insignia in this Article.



- ★ 1117.2.o. Officer in Charge Insignia. A sterling silver metal pin consisting of a rope grommet with fouled anchor and a Coast Guard shield superimposed on anchor which is $13/16$ " in height and $23/32$ " in width.



- ★ 1117.2.p. Coxswain Insignia. A silver plated, oxidized relieved satin finish consisting of curled waves and crossed oars with a superimposed compass rose which is $3/4$ " in height and 2" in width.

- ★ 1441.2. Manner of Wearing. The letter device "O" will be worn in a manner similar to the Combat "V" on both medals and ribbons. Except for the manner of wearing, this device is not to be confused with or in any way related to the Combat "V". It cannot be issued in lieu of or as part of any individual award for which a Combat "V" was authorized. It may be worn with a Combat "V" but only when it has been issued for a separate award from the one which authorized the Combat "V". Only one Operational "O" device will be worn on each medal/ribbon. When the Operational "O" and Combat "V" are worn on the same medal/ribbon the "O" will be worn on the inboard side. All additional awards of the same decoration will be a gold/silver star in lieu of a second or subsequent award as prescribed in Article 1440.
- ★ 1441.7. Silver Letter "O". Individuals who have been awarded the Coast Guard Commendation Medal, Coast Guard Achievement Medal, or Coast Guard Unit Commendation Ribbon for operational performance may be authorized to wear a silver letter O. The manner of wearing will be as prescribed in Article 1441.2.
