C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands on the site are abutting Spring Creek (main channel) and another branch of the stream. The wetlands are also abutting the Teton River as part of a large wetland complex to the east of the river. The Teton River is a TNW. There is a robust guided fishing/float industry on the Teton River with stops at local lodges. Spring Creek (main channel) is perennial

according to review of aerial photography, NWI maps, and USGS quad sheets. The north arm of the creek that is located on the northern portion of the parcel also appears to be perennial based on aerial photography and NWI maps, although USGS Quad maps show it is intermittent. This is suspect however, given its position in the landscape, i.e. bottom of the valley near the river. It is possible that it is dewatered during some portion of the year due to irrigation diversions/manipulation for irrigation.
